## **Brief Summary and Statement of Need:**

fundamental to all successful communities. Historic properties provide continuity with the past, attract visitors, create a sense of civic pride and provide opportunities to enrich the education of our children.

### **Project Support:**

The project is supported by land managers, developers, historic preservation organizations, local and tribal governments, owners of historic properties, and State and federal agencies.

### **Project Opposition:**

Most public participation in the program is voluntary. Agency participation is required by state and federal law.

#### **Project History:**

In the past five years, the State has received approximately \$2,100,000 from the national Historic Preservation Fund. Cooperative Agreements and Direct Grants account form approximately \$1,000,000 received by the State from special cultural resource management projects. The State has received NHPF grants annually since 1971.

### Annual Operating and Maintenance Costs:

\$282.4 general fund match in the State Historic Preservation Program component operating budget. The NHPF program requires a 40% match from the state. Pass-through NHPF grants to Certified Local Governments also require a 40% match.
