## **Component Mission**

To prepare, and support local fire and rescue agencies in emergency response activity.

## **Component Services Provided**

- Training and certification of local fire and emergency responders.
- Adoption of national fire training standards and the development of curriculum based on those standards.
- Accreditation of emergency response training programs based on national training standards.
- Technical assistance to communities regarding the organization, training, and response capabilities of their local departments.
- Management of U.S. Fire Administration programs for Alaska including all National Fire Academy courses and the Anti-Terrorism Response Training program.
- Training of Alaska Emergency Response groups including the U.S. Coast Guard shipboard firefighters, Cruise Line fire response teams, and other industrial fire brigade response teams.
- Provide fire and emergency response information management and statistics.

#### **Component Goals and Strategies**

- Enforcement of all laws and ordinances under AS 18.70.000-18.70.100 relating to fires, fire prevention and protection.
- Administer the state fire service training program.
- Administer the emergency responder certification program.
- Develop and adopt new training and certification programs.
- Accredit local department training programs to meet state and national training standards.
- Administer the Alaska fire incident reporting program, and prepare and disseminate related information and statistics.
- Provide assistance and support to the Alaska Fire Standards Council.
- Provide fire and emergency response training for the Village Public Safety Officers.
- Encourage fire prevention education.
- Administer the fire grants program.
- Provide training of various Alaska emergency response groups including the U.S. Coast Guard shipboard firefighters, cruise line fire response teams, and other industrial fire brigade response teams.

## **Key Component Issues for FY2003 – 2004**

- Until the Alaska Fire Standards Council is funded the Fire Service Training component will continue to assume
  the functions and responsibilities of the council. These functions include accreditation of local fire department
  training programs, certification of fire fighters and instructors and assistance to develop new certifications based
  on national standards.
- Capabilities of small rural fire departments are in need of improvement. This is best accomplished through support of programs such as the Rural Basic Firefighter program supported by Alaska Village Initiatives.
- If the FY 2004 Increased Variable Benefit Costs in Working Reserve and PERS rates are not funded, classes to local fire departments and first responders will be reduced.

## **Major Component Accomplishments in 2002**

- Developed certification standards and curriculum for certification at the Airport Firefighter, Rural Basic Firefighter, and Fire Instructor I and II levels.

## **Proposed Changes in Levels of Service for FY2004**

The Legislature approved an RPL in FY2003 for Alaska Rural Village Fire Suppression Capabilities. This RPL provided authority to receive and expend \$290.0 Statutory Designated Program Receipts from Alaska Village Initiatives (AVI) to conduct critically needed fire training in 29 rural communities in Alaska. This project is also known by the AVI project name of "Code Red".

It is anticipated that this project will continue in FY2004, and an increment is being requested in the amount of \$520.0 to provide the authority to receive and expend Statutory Designated Program Receipts to conduct this fire training in 52 additional villages during FY2004.

Upon approval of the increment, Fire Service Training will provide logistical support, equipment, and training knowledge for the entire training element. The increment includes funding for one part-time, long-term, non-perm fire training specialist position.
