#### **Component Mission**

The mission of the Division of Alaska State Troopers is to preserve the public peace and to protect life and property.

#### **Component Services Provided**

The Criminal Investigation Bureau (CIB) is assisted by the primarily federally funded Narcotics Task Force (NTF) to enforce statutes related to controlled substances. The CIB and NTF-funded investigators comprise the Statewide Drug Enforcement Unit, which investigates trafficking of controlled substances and illegal alcohol throughout the state.

#### **Component Goals and Strategies**

The goals of the Statewide Drug Enforcement Unit, which is funded in the Criminal Investigation Bureau and Narcotics Task Force components is to solve sophisticated criminal cases involving controlled substances on a statewide basis through detection, apprehension, and assistance in the prosecution of individuals suspected of violating controlled substances law.

#### Key Component Issues for FY2003 - 2004

ILLEGAL DRUG AND ALCOHOL ENFORCEMENT - The Statewide Drug Enforcement Unit (SDEU) has taken the lead role in almost all regions of the state in coordinating the investigative efforts involving illegal alcohol and drugs.

Two members of the Statewide Drug Enforcement program are dedicated to the interdiction and investigation of illegal alcohol shipments into villages that have voted to exercise their local option to either limit or prohibit the possession and/or importation of alcoholic beverages.

The remaining members of the Statewide Drug Enforcement Unit are involved in investigating drug and illegal alcohol violations across the state. The unit works closely with a multitude of other agencies in nearly all locations in order to accomplish its mission.

# **Major Component Accomplishments in 2002**

The unit continues its aggressive pursuit of all leads concerning clandestine methamphetamine laboratories in order to keep this problem from spreading beyond the areas that are already feeling its affects.

During FY2002, the Anchorage Airport Interdiction Team, which is made up of members from AST, Airport Safety, and the Alaska National Guard Counter Drug Support Program, entered into a formal agreement to participate in a Drug Enforcement Administration (DEA) task force. The task force is dedicated to intercepting illegal drugs and alcohol as the substances are transported throughout the state and to assist in the conviction of offenders.
