#### **Component Mission**

The Bristol Bay Campus, College of Rural Alaska of the University of Alaska Fairbanks seeks to provide educational opportunities through which Alaskans, particularly Alaska Natives and rural residents, are empowered to effect social and economic changes in their communities as well as to protect and enrich the quality of their lives and culture.

#### **Component Services Provided**

The UAF Bristol Bay Campus is located in Dillingham on the western coast of Bristol Bay. The campus serves thirty-three villages in an area of approximately 55,000 square miles through distance delivery, correspondence, itinerant instructors, and more traditional methods.

Academic and vocational courses are offered throughout the Bristol Bay region. The campus offers an Associate of Arts degree in general studies and Associate of Applied Science degrees in applied accounting, applied business, apprenticeship technology, community health, early childhood, human service technology, interdisciplinary studies, microcomputer support specialist, office management and technology and renewable resources. Bachelor's degrees are available in elementary education, rural development, social work and interdisciplinary studies. A master's degree program in rural development is available to Bristol Bay residents.

#### **Major Component Accomplishments in 2002**

#### Unity in promoting communication and collaboration

The Bristol Bay Campus, in partnership with the Interior-Aleutians Campus, started a spring 02 cohort under the \$1.8 million, five-year, Hutlee-Umyarchdelee National Science Foundation math, science, engineering, and technology grant.

#### Accountability to students, faculty, staff, alumni, and the diverse peoples of Alaska

The Bristol Bay Native Association is planning the first Annual Early Childhood Conference and is working closely with Bristol Bay Campus for credit and advising.

#### Leadership for Alaska's people and institutions

The Bristol Bay Campus' Adult Basic Education Program completed its 20th year of operation and graduated twenty-one GED students during the 2001-02 year. The Adult Basic Education/GED program was funded by a \$106,420 grant from the State Department of Education.

The Bristol Bay Campus graduated fifteen postsecondary students at the 16th annual commencement exercises on May 18, 2002. UAF Chancellor Marshall Lind was the commencement speaker.

The Bristol Bay Campus, in cooperation with its partners, Bristol Bay Native Association, Bristol Bay Economic Development Corp., Bristol Bay Housing Authority, and SAVEC, assisted in the development of a statewide Memorandum of Agreement between the microcomputer support specialist program (MSS Program) and the Alaska Vocational and Technical Center (AVTECH) toward the goal of providing AVTECH's computer technology instruction to Bristol Bay residents and credits toward the University of Alaska's MSS Program.

#### **Excellence in programs and services**

The Bristol Bay Campus, in partnership with SAVEC, served the Bristol Bay region for the first time through the King Salmon vocational training program. The partnership provided 23 credits of vocational training and 1.5 Continuing Education Units of training to 83 students.

#### Accessibility for all Alaskans

The Bristol Bay Campus received a \$100,000 National Oceanic and Atmospheric Administration grant to strengthen student access into the land management and renewable resources programming.

#### **Dedication to serving community needs:**

The Bristol Bay Campus received \$400,000 of U.S. Department of Housing and Urban Development grant funding to provide training in the field of construction and technology for eight distressed communities in Bristol Bay. This grant will enable the Bristol Bay Campus and its partner, the Southwest Vocational and Educational Center (SAVEC), to provide streaming video instruction to eight Bristol Bay communities.

#### Stewardship of our resources:

The Bristol Bay Campus was funded for its second year of a five-year Title III A-Strengthening Institutions Grant for a total of \$395,000. In addition to adding student services staff, this grant enabled the campus to hire an academic program director responsible for redeveloping a land management/renewable resources program being piloted in Bristol Bay for the entire college.
