## **Additional Information / Prior Funding History:**

Previous projects for hazardous materials response capabilities for local government have received prior appropriationsof 500.0 in FY1998; 300.0 in FY1999; 200.0 in FY2001; and 500.0 in FY2002 as well as Alaska Spill Depot and Corps System 300.0 in FY2004. Other related projects have received prior appropriations as follows: "Local Community Response Training and Equipment" - 400.00 in 1995; "Local Response Agreements - Equipment, Training, and Prepardness" - 200.0 in FY1998 and 500.0 in FY1999.

#### **Project Description/Justification:**

In accordance with its statutory obligations, DEC is required to respond to oil and hazardous materials (HAZMAT) releases throughout Alaska. DEC may satisfy this responsibility through contracts with persons or municipalities or, in the absence of these resources, may elect to establish and maintain this capability within the department.

DEC has entered into formal response agreements with the communities of Fairbanks, Anchorage, and Valdez all of which maintain a credible hazardous materials (HAZMAT) response capability. These agreements allow DEC to dispatch these teams outside their local jurisdiction to any location in the state to respond to a HAZMAT release. These teams repond at the direction of DEC, as part of a state team.

This project will provide funding for equipment, preparedness, and training costs for the HAZMAT Teams in Anchorage, Fairbanks, Valdez and Southeast Alaska, augmenting their capability to allow response outside the service areas of their

normal jurisdictions and providing expanded statewide coverage. Funding may also be used to provide on-site, non-regulatory technical assistance visits; ammonia and chlorine response training; and exercises at communities which face the risk of a life-threatening chemical release.

Cooperative and successful HAZMAT projects and training exercises have been held in Petersburg, Kodiak, Unalaska, Bristol Bay, Healy, Nenana, and Whittier.
