In the coming year, this will include activities related to the development of bridges to Gravina Island, access to Juneau, an extension of Abbott Loop Road in Anchorage, a Knik Arm Bridge, and resource development roads. The section will provide assistance should negotiations with Alaska Marine Highway System employees result in a strike. The section also expects significant effort on a construction claim relating to the reconstruction of passenger terminals at the Ted Stevens Anchorage International Airport.
