Component Budget Summary

#### **Component: Southeast Region Highways and Aviation**

#### **Contribution to Department's Mission**

Operate, maintain, protect and control the state's highway, harbor and airport systems.

#### **Core Services**

- Winter snow and ice control including: snow plowing, snow removal, sanding, de-icing, avalanche control, snow fencing and culvert thawing.
- Summer maintenance including: grading, pothole patching, crack sealing, leveling of heaves and dips, brush
  clearing, sweeping, dust control, drainage cleaning and repair, fence and guardrail repair, bridge painting and repair,
  and sign maintenance.
- Road and airport lighting systems including: maintenance of traffic signals, intersection and road illumination, harbor electrical service and lighting, and runway and taxiway lights.
- · Airport security including: access control, badging, lock and key control, and fencing.
- Airport compliance, including inspection and assurance that state airports are operated in accordance with FAA
  operating regulations.
- Access control to state rights of way for driveways, access roads, signs and utilities.
- Maintenance of harbor facilities not maintained by local community, including breakwaters, floats, and electrical systems.
- Statewide winter road and weather reporting on the Internet and the statewide recorded messaging system.
- Operation of the Adopt-a-Highway system.
- Provide an active avalanche prevention program.

#### **Key Component Challenges**

- The major challenge to Southeast Region Highways and Aviation is providing safe highways and airports while keeping cost per lane mile at current levels. As the highway and airport infrastructure deteriorates, cost of maintenance increases. The cost of personal services, equipment rental, and commodities increases each year. New regulations and standards, mandated by FHWA, FAA, and EPA, make additional demands on the budget. The H&A budget has not kept up with these increased demands and is inadequate to sustain basic preventative maintenance of our roads and airports.
- Increased costs have been offset to some degree by use of federal capital funds. Highways and Aviation has made maximum use of federal highway funding to achieve major improvement of road surfaces (chip sealing), which decreases maintenance costs for the short term. Operating costs, however, have continued to outweigh the sum of our cost-reducing efforts, the infusion of capital funds, and our operating revenues. These budget shortfalls have mandated that we focus our maintenance efforts on urgent repairs rather than conduct a systematic preventative maintenance program for all transportation infrastructures. We are unable to dedicate adequate maintenance efforts

to highly deteriorated sections of high volume roads (such as South Tongass Highway), low volume roads, remote harbor facilities, and seaplane floats.

Airport security program requirements have increased dramatically requiring personnel to perform mandated
functions such as security management, inspection, access and perimeter patrols, and administrative functions.
Considerable costs will continue to be incurred to provide security fences, lighting equipment, access controls and
additional security vehicles. All persons who require unescorted access to aircraft secure areas must have a
fingerprint-based Criminal History Records Check (CHRC) that shows no convictions for disqualifying crimes.
Increasingly thorough badging requirements are in place for background checks and badging of all persons requiring
access to airport secure areas.

#### Significant Changes in Results to be Delivered in FY2006

• Funds are included in this budget request to cover the increasing costs of employee benefits, equipment usage, and commodities such as steel, fuel, and winter abrasives. Funding at the proposed level will allow us to provide the same level of service as in previous years.

#### **Major Component Accomplishments in 2004**

- Began the implementation of the computerized Maintenance Management System (MMS). Computers will be used to submit daily work reports, and are coming on-line at various maintenance stations following foremen training.
- Began putting the Land Mobile Radio repeaters on-line. The Juneau area now has better coverage.
- Gustavus: Completed temporary repairs to the state dock, addressing the most pressing safety issues to allow it to remain in service pending major repairs..
- Haines: Completed emergency repairs to the Haines Highway to prevent river erosion from destroying a one mile section of the highway.
- Hyder: Repaired major erosion site on Salmon River Road to restore two lanes of traffic and protect bank against further erosion.
- Juneau: Replaced damaged culverts on Thane and Douglas Highways. Completed road preparation work on Herbert River Truck Trail for hard surfacing and transfer to the City and Borough of Juneau. Completed major ditching, brushing, and guard rail cleaning on various highways in the Juneau area.
- Kake: Repaired runway surface at Kake Airport. Cut brush on airport and repainted airport markings.
- Ketchikan: Completed extensive ditching and brushing; performed numerous spot repairs of deteriorating pavement on North and South Tongass Highways.
- Klawock: Completed major FHWA funded project, including chip seal repair of 10 miles of Hydaburg Highway and ditching and brushing of the entire highway. Painted airport markings.
- Petersburg: Painted and crack sealed Petersburg Airport runway. Repaired failed culvert on Mitkof Highway.
- Sitka: Performed emergency repair of Indian River Bridge.
- Skagway: Completed building pad for maintenance building on Klondike Highway. Completed .5 miles of shoulder improvements for snow storage on Klondike Highway.
- Wrangell: Completed emergency repair of bank erosion on Zimovia Highway. Coordinated a complex quarry mining and blasting operation on the airport with no adverse impact on air traffic.
- Yakutat: Completed emergency repair of Alsak Road. Applied aggregate material to improve surface of Situk Road. Provided aviation safety assistance to a major runway paving project with no major safety violations.
- Region-wide: Performed extensive ditching and brushing on roads and airports throughout the region. Painted and striped highways throughout the region.
