Continue expanding administrative adjudication services to encompass additional case categories assigned to and voluntarily referred to this office and providing training to administrative adjudicators.

Major Component Accomplishments in 2005

Integrated three separate departments' hearing functions into one central hearing panel with two offices. Conducted hearings for or performed other adjudication-related work on more than 800 cases. Implemented case management procedures, including "rapid case resolution" for high volume cases.
