Contribution to Department's Mission

Preserve public peace, protect life, property, and resources.

Core Services

The mostly federally funded Narcotics Task Force (NTF) is organizationally part of the Alaska Bureau of Alcohol and Drug Enforcement (ABADE), which investigates trafficking of controlled substances and illegal alcohol throughout the state. The unit is budgeted as a separate component to allow expenditure of the federal grant funds to be easily tracked.

The goal of ABADE is to solve sophisticated criminal cases involving controlled substances and illegal alcohol on a statewide basis through detection, apprehension, and assistance in the prosecution of individuals suspected of violating controlled substances law and state alcohol laws.

Key Component Challenges

The ABADE has taken the lead role in almost all regions of the state in coordinating the investigative efforts involving illegal alcohol and drugs.

Five members of the ABADE program are dedicated to the interdiction and investigation of illegal alcohol shipments into villages that have voted to exercise their local option to either limit or prohibit the possession, sale, bartering, and importation of alcoholic beverages.

The remaining members of the ABADE are involved in investigating drug and illegal alcohol violations across the state. The unit works closely with a multitude of other agencies in nearly all locations in order to accomplish its mission.

Congress reduced the amount of federal funding available to DPS for drug enforcement programs in FFY2005 by approximately 60 percent. Congress eliminated the federal Byrne Formula Grant and Local Law Enforcement Block Grant programs and replaced them with the Edward Byrne Memorial Justice Assistance Grant (JAG) program. The FY2005 Byrne award to ABADE was \$1,140.6 compared to \$482.2 in FY2006; a reduction of \$658.4 in federal funds. In addition to the reduction to the ABADE, awards to local police agencies, the Department of Law, and other DPS divisions were also significantly reduced.

Significant Changes in Results to be Delivered in FY2007

The JAG funds that go specifically to ABADE are used for the most part to pay for narcotics investigators. In the event that the reduction in JAG funds is not replaced with general funds, ABADE will face the elimination of up to six of its ten JAG-funded positions. The only alternative would be to reduce allocations to other components to make up the shortfall. If the shortfall were replaced by general funds, ABADE operations could continue at the level seen in FY2005 (see below).

Major Component Accomplishments in 2005

The unit continues its aggressive pursuit of all leads concerning clandestine methamphetamine laboratories in order to keep this problem from spreading beyond the areas that are already feeling its effects.

During FY2002, the Alaska Interdiction Task Force, made up of members from AST, Airport Safety, and the Alaska National Guard Counter Drug Support Program, entered into a formal agreement to participate in a Drug Enforcement Administration (DEA) task force. The task force is dedicated to intercepting illegal drugs and alcohol as the substances are transported throughout the state and to assist in the conviction of offenders.
