This amendment to the FY2009 Governor's Budget revises the project description and adds \$2,500,000 Federal Receipts for a new FY2009 total of \$5,500,000. The Alaska Highway Safety Office coordinates highway safety programming through federally funded grants directed toward public outreach and education; enforcement; promotion of new safety technology; integration of public health strategies; collaboration with safety and private sector organizations; and cooperation with state and local governments. ### **Project Description/Justification:**

The Alaska Highway Safety Office manages highway safety program funds from the National Highway Traffic Safety Administration (NHTSA). Federally funded grants are directed toward public outreach and education; enforcement; promotion of new safety technology; integration of public health strategies; collaboration with safety and private sector organizations; and cooperation with state and local governments. The 50% match requirement for the program administration grant is part of the Other Federal Program Match request (RefNum 41932).

#### Section 402 - STATE AND COMMUNITY HIGHWAY SAFETY GRANT PROGRAMS

These grants support a state highway safety program designed to reduce traffic crashes and resulting deaths, injuries, and property damage. Funding is used to identify highway safety problems, set goals and performance measures for highway safety improvements, provide start-up money for new programs, give direction and support to existing safety programs, and fund analyses to determine progress in improving safety.

completeness, uniformity, and accessibility of state data that is needed to identify priorities for national, state, and local highway and traffic safety programs; to evaluate the effectiveness of efforts to make such improvements; to link these state data systems, including traffic records, with other data systems within the state; and to improve the compatibility of the state data system with national data systems and data systems of other states to enhance the ability to observe and analyze national trends in crash occurrences, rates, outcomes, and circumstances. A state may use these grant funds only to implement such data improvement programs.

#### Section 405(a) - OCCUPANT PROTECTION INCENTIVE GRANTS

These grants encourage states to adopt and implement effective programs to reduce highway deaths and injuries resulting from individuals riding unrestrained or improperly restrained in motor vehicles.

#### Section 157 - SAFETY INCENTIVE GRANTS FOR USE OF SEAT BELTS

The funds help encourage states to increase seat belt use rates.

#### Section 157 - SAFETY INNOVATIVE GRANTS FOR USE OF SEAT BELTS

This program provides funding to increase police enforcement of seat belt and child restraint laws and public education efforts on the use of seat belts and child restraints.

#### Section 405b (aka 2003b) - CHILD PASSENGER SAFETY INCENTIVE GRANTS

These grants encourage states to adopt and implement effective programs to reduce highway deaths and injuries resulting from children riding unrestrained or improperly restrained in motor vehicles.

#### Section 408 - STATE TRAFFIC SAFETY INFORMATION SYSTEM IMPROVEMENTS GRANTS

The purpose of this grant program is to support the development and implementation of effective programs to improve the timeliness, accuracy, completeness, uniformity, integration and accessibility of the safety data that States need to identify priorities for national, State and local highway and traffic safety programs.

#### Section 410 - INCENTIVE GRANTS FOR ALCOHOL-IMPAIRED DRIVING PREVENTION PROGRAMS

The purpose is to encourage States to adopt and implement effective programs to reduce traffic safety problems resulting from individuals driving motor vehicles while under the influence of alcohol.

#### Section 2010 - INCENTIVE GRANTS FOR MOTORCYCLIST SAFETY PROGRAM

Incentive grants to States that adopt and implement effective programs to reduce the number of single- and multi-vehicle crashes involving motorcyclists.
