Component: Central Region Construction and CIP Support

Contribution to Department's Mission

Improve the transportation system in Alaska and protect the health and safety of Alaska's people by constructing safe, environmentally sound, reliable and cost-effective highways, airports, harbors, docks, and buildings.

Core Services

Director's Office: Division general management.

Construction Branch: Administers construction contracts, provides field inspection and construction oversight, provides quality assurance that construction documentation and materials are in conformance with contract requirements during construction and closeout of projects, and reports Disadvantaged Business Enterprises/Minority Business Enterprise activity on construction projects.

Contracts Branch: The Construction Contract Unit reviews construction documents, provides bid packages, advertises and awards contracts, prepares certified bid tabulations, and helps resolve bidding disputes. The Professional Services Agreement Unit coordinates, solicits, selects, prepares and administers professional services agreements.

Project Control Branch: Coordinates and programs project funding; administers state and federal grants; provides engineering management support; develops, enhances, and maintains capital projects information for the management reporting system; provides regional network administration and desktop computer support; and processes time and equipment charges to projects.

Public Facilities Branch: Effective September 1, 2007 the Public Facilities Branch has been transferred from Central Region to the status of a statewide component. The new component, Statewide Public Facilities, remains in the Design and Construction RDU and reports to the Deputy Commissioner of Highways and Facilities.

Key Component Challenges

- Compliance with storm water permitting requirements for construction projects has become a priority for the Environmental Protection Agency (EPA). The Department will need to continue to emphasize storm water permitting through training, high level field inspections, partnering with permitting agencies, and improved policies and procedures.
- The department's goal is to keep total construction administration within 14.5 percent of the final contract cost. This will be difficult to meet when consultant administrative services are used and federal reporting requirements need to be maintained.
- In an effort to help managers measure performance and ultimately close out projects in a more timely manner, the Division will pursue implementation of new technologies that will continue to streamline record keeping, project reporting, and overall document management.
- It is essential for the Department to maintain a professional and stable work force. The Department will need to identify and promote new incentives to attract and retain qualified employees.
- The Central Region Headquarters building has insufficient space to accommodate personnel and storage needs. Options and funding for new office space will need to be identified.

Significant Changes in Results to be Delivered in FY2009

No significant changes anticipated.

Major Component Accomplishments in 2007

- Received \$99 million in federal highway construction authorization (state match is in addition to this amount) in FFY07 which includes Advance Construct (AC) authority.
- Received \$73.2 million in federal aviation authorization (state match is in addition to this amount) in FFY07, of which the majority was allocated to the construction phase.
- Awarded \$38.5 million in general fund construction and design/build contracts for highway projects.
- · Completed runway, taxiway, apron, lighting, and safety improvements at rural airports in Bethel New Stuyahok, and King Salmon. Began airport improvements at Manokotak, Tuntutuliak and McGrath.
- Completed construction of airside improvements at Ted Stevens Anchorage International Airport including Runway 7R / 25L emergency resurfacing, remote overnight parking and refueling stations 7 – 11, reconstruction of Gate N6 and reconstruction of Taxiwav U.
- Completed rut repair and resurfacing of 9 miles (27 lane miles) on the National Highway System (NHS) for the Seward Highway from MP 37-43 and Parks Highway through Wasilla from MP 41-44.
- Completed rut repair and resurfacing of 8.9miles (17.8 lane miles) of Non-National Highway System routes on the Kenai Peninsula, Oilwell Road and Norfork Road.
- Continued commitment to upgrade NHS routes to meet current standards for width, grade, alignment and safety with commencement of reconstruction of the Glenn Highway from MP 92-97 and completion of the new bridge over the Kenai River in Soldotna on the Sterling Highway.
- Continued construction with substantial completion and opening in November 2007 of the general obligation bond funded Abbott Loop extension and reconstruction project that will provide a new transportation corridor to alleviate congestion within the Anchorage Bowl.
- Completed construction of the extension of C Street from Diamond Boulevard to O'Malley Road including a grade separated interchange at O'Malley Road to include roundabouts at the C Street on-off ramp.
- Awarded design/build contract, with commencement of construction for the general funded Glenn Highway and Bragaw Interchange project.
- · Continued making safety awareness in construction traffic zones a priority by educating the public through use of the changeable message board, use of appropriate "double fine" construction zones, and contract for increased enforcement through the Alaska State Troopers and the Anchorage Police Department in construction worksites. Increased safety awareness on high accident routes with the designation of the Parks Highway from Wasilla to Big Lake as a "Traffic Safety Corridor."
- Increased safety for the traveling public with completion of improvements such as signalization, channelization and striping at the intersections of Muldoon Road at 33rd, Hallligan and Westbrook in Anchorage and at the Willow and Main Street intersections in Kenai. New avalanche gates were installed along the Seward and Sterling Highways.
- Completed Kenai Peninsula flood repair work at the Seward Airport, a new bridge at Stariski Creek (MP 150.6 of the

Sterling Highway) and embankment and culvert repairs at Anchor River, Diamond Creek, Ninilchik River and Unnamed Creek along the Sterling Highway.
