Project Description/Justification:

To defray the cost of transition to city or borough government and to provide for interim government operations, each city incorporated, or each borough or unified municipality incorporated after December 31, 1985, is entitled to an organization grant under Alaska Statute 29.05.180 - .200.

Each city or second class city incorporated after December 31, 1985, is entitled to an organization grant as follows:

- (1) \$50,000 for the first full or partial fiscal year after incorporation; and
- (2) \$25,000 for the second fiscal year after incorporation.

Each borough or unified municipality incorporated after December 31, 1985, is entitled to organization grants as follows:

- (1) \$300,000 for the municipality's first full or partial fiscal year;
- (2) \$200,000 for the municipality's second fiscal year; and
- (3) \$100,000 for the municipality's third fiscal year.

The City of Wrangell incorporated in fiscal year 2008. They received first year funding in an FY08 Supplemental. The second year's funding (FY09) for Wrangell was appropriated in FY09. This request is for the 3rd and final year grant of \$100,000.
