Key Component Challenges

Fuels mitigation projects, funded with federal earmarks directly to Boroughs or Municipalities, have provided excellent opportunities for wild land fire crews to be located in key positions to respond to urban-interface fires while performing much needed fuels reduction projects. This training and experience in both resources and fire is excellent, but more importantly it keeps crews employed and together between fire mobilizations since they are not hired as seasonal employees, but are hired as temporary Emergency Fire Fighters

The challenge is that federal funding to support these crews has been decreased significantly this year, making it problematic as to whether the crews will be sustained. These are either currently Type 1 Hotshot Crews or very experienced Type II crews that provide a first line of defense against fires such as the Piper Fire that occurred within the Municipality of Anchorage's Campbell Creek Greenbelt this last summer. Funding for these crews may require participation at the State, Borough or Municipal levels to be successful.

Significant Changes in Results to be Delivered in FY2010

No proposed changes.

Major Component Accomplishments in 2008

During FY08, progress on three major projects was accomplished utilizing nonpermanent field crews:

The Pioneer Peak Crew worked on hazard fuels mitigation projects in the Municipality of Anchorage. The work consisted of shaded fuel breaks, reducing fuel loading, thinning and limbing and overall stand health improvement. The work involved reduced the potential for serious wild land fires on the Anchorage Hillside, in Bird Valley and in the Eagle River drainage. The Bird Valley and Eagle River sites were located on State Park Lands and were completed as part on an interagency effort to reduce the potential of fire spread from a fire started on State lands. Two Anchorage locations were done in conjunction with the Anchorage fire department on Municipality of Anchorage lands. The Anchorage sites were adjacent to urban development's and conducted as part of the Community Wildfire Preparedness Plan. Federal funds were received through the Municipality of Anchorage as part of the National Fire Plan.

The Gannett Glacier hand crew worked on ten fuels projects for a total of 48 days throughout the Mat-Su Borough. The fuels reduction work was completed around high value public buildings and facilities. These sites included four schools. In all over 1,800 piles of slash were piled and burned, significantly reducing the fuel loading around these facilities. Fuels reduction was also completed around the City of Huston Camp Ground. The fuels reduction

completed at this site was not only completed to reduce the fuel loading but as an example of proper defensible space, and Firewise practices.

The Denali type 2 fire crew, which is hired by Chugachmiut Corporation with support from the Division and the Bureau of Indian Affairs, worked for approximately six weeks to mitigate hazardous fuel adjacent to public facilities to reduce the potential for serious wild land fires. The crew worked primarily on borough owned lands around public school facilities, within city parks of both Kenai and Soldotna, and in State campgrounds: Kasilof River, Crooked Creek, and Clam Gulch. The Kenai Peninsula Borough federal Spruce Beetle Task Force and BIA Hazard Fuel Reduction funding was used to accomplish the hazard fuels reduction projects.
