Continue to work with private sector to provide employment and income for prisoners to help offset cost of incarceration and to assist the prisoner in paying child support and/or restitution.

Significant Changes in Results to be Delivered in FY2010

Major Component Accomplishments in 2008

The Hiland Mountain Correctional Center (HMCC) Garment Shop produced 116 of the 50 Year celebration banners commemorating Alaska Statehood. They are currently on display at the Anchorage International Airport and all other airports across the State of Alaska. One of the 25 foot banners was displayed with the American Flag above the stage at the Wynona Judd concert. This televised event was held at Elmendorf Air Force Base.

The Prison Employment Program (PEP) has obtained the following new customers: Alaska Parka Design/Laura Wright Parka, Eagle River Parks and Recreation, Fort Richardson 59th Signal Battalion, Eagle Enterprises, Ketchikan Fish Market, Made in Alaska program, Mat-Su School District.

PEP has acquired the HMCC Greenhouse. The first year of operations resulted in significant sales compared to past sales. 2008 Memorial Day week-end resulted in records sales of over \$30,000 in three days.

The HMCC Garment Shop hired, trained and employed 158 inmates in FY2008.

PEP in Lemon Creek Correctional Center (LCCC) employed as many as 20 prisoners at any given time during the busy summer months and as few as 10 prisoners during the winter months.

LCCC PEP processed approximately 770,000 lbs. of laundry in FY2008 providing a needed service to not only the State of Alaska, but also the tourism industry, and a private nonprofit institution.

The LCC PEP Laundry Program contracted laundry services for three additional cruise ships, Empress of the North, Sea Lion, and Sea Bird beginning with the tourist cruise ship season of 2008.
