#### **Major Component Accomplishments in 2008**

The CAMA program provided payment for 1,205 individuals within the appropriated general fund amount in FY2008 through regulations that reduced services provided and aggressive management of claiming adjustments for payments made by CAMA for individuals who became Medicaid eligible.

The majority of the expenditures in the CAMA program were for medications for the chronically mentally ill and individuals with diabetes.
