#### **Component: Tribal Assistance Programs**

## **Contribution to Department's Mission**

Provides funding to support Native Family Assistance programs. Tribes and Alaska Native organizations are allowed to operate tribal Temporary Assistance for Needy Families (TANF) programs. State law allows the department to provide funding to Native organizations operating tribal TANF programs. These are known as Native Family Assistance programs.

#### **Core Services**

This component provides funding for benefit payments to recipients of a federally approved tribal Temporary
Assistance to Needy Families program. The amount provided is a prorated share of state funds that would
otherwise be spent to serve eligible Native families through the Alaska Temporary Assistance program.

## **Key Component Challenges**

- Increased service coordination for Native families receiving benefits from Native Family Assistance
  Programs and other types of public assistance such as Medicaid and food stamp benefits, shared use of
  Division of Public Assistance's Eligibility Information System, and technical assistance to support the
  development and implementation of Tribal TANF programs.
- Kodiak Area Native Association and Maniilaq Association are planning to implement Native Family
  Assistance Programs in FY09. The Metlakatla Indian Community has also filed a letter of intent to implement
  a Native Family Assistance Program in the future.

# Significant Changes in Results to be Delivered in FY2010

• Implementation of Kodiak Area and Maniilaq Native Association's Native Family Assistance Programs will increase the number of Tribal TANF programs operating in Alaska from five to seven, and will result in a small increase in the number of families served by Native Family Assistance Programs.

#### **Major Component Accomplishments in 2008**

- Provided resources, funding, technical support, policy guidance, training and system support to the five Native Organizations running Native Family Assistance programs. The five Native organizations now running Native Family Assistance programs include: Association of Village Council Presidents (AVCP), Central Council of Tlingit and Haida Indian Tribes of Alaska (CCTHITA), Tanana Chiefs Conference (TCC), Cook Inlet Tribal Corporation (CITC), and Bristol Bay Native Association (BBNA).
- Approximately 1,600 families are now receiving temporary assistance benefits and services from the Native Family Assistance programs.
- Monitored and accurately accounted for the state share of child support collected on behalf of children served, by Native Family Assistance programs, totaling \$843.5 in FY08.
