Contribution to Department's Mission

Health Planning and Infrastructure works with communities and organizations to assure access to quality primary and acute health care services in Alaska.

Core Services

- Manage multiple state and federally funded programs that strengthen health care access with a focus on rural areas and underserved populations.
- Conduct statewide health planning to help sustain organized and efficient health care delivery in Alaska.
- Provide technical assistance to hospitals, primary care delivery sites, and other community organizations
 regarding health care delivery, health care workforce, health care financing and reimbursement, and health care
 facilities.

Key Component Challenges

- Coordinating various state health plan development and analysis activities, including hospital discharge data system and comprehensive integrated mental health planning.
- Managing Certificate of Need (CON) project reviews, regulations and requests for CON determinations.
- Measuring and developing strategies to address the lack of access to health care and insurance.

Significant Changes in Results to be Delivered in FY2010

New projects underway in FY2009 and FY2010 will provide 1) an oral health workforce development plan for Alaska, supported by a federal grant, and 2) preliminary results of a pilot project analyzing hospital and outpatient data in relation to motor vehicle crashes.

Major Component Accomplishments in 2008

- Provided technical assistance on health care services and funding to over 225 communities. Results included communities being awarded 16 Community Health Aide Training and Supervision grants.
- Reviewed all Certificate of Need (CON) applications that were submitted. Implemented statutorily required
 changes that strengthened the CON program on issues of facility ownership, leased equipment and new
 service types. Implemented statewide health care plan that sets preliminary standards for CON.
- Updated the Comprehensive Integrated Mental Health Plan (Comp Plan) (Moving Forward) website;
 facilitated and staffed planning and data groups for interagency collaborative development of a scorecard of leading indicators and analysis of the system of care.
- Implemented health care workforce recruitment and retention programs that resulted in rotations for 57 health professions students and residents in 26 underserved sites throughout Alaska; placed health care providers funded by National Health Services Corps; and served on various workforce-related statewide committees and boards.

• Managed the Community Health Aide training and supervision grant program that provides approximately \$1.7 million to 16 tribal organizations.
