### **Contribution to Department's Mission**

The Workers' Compensation Appeals Commission component contributes to the department's mission by ensuring timely, thoughtful, well-reasoned and sound decisions on appeals from final decisions and orders of the Workers' Compensation Board.

## **Core Services**

- Adjudicate appeals from disputed Workers' Compensation Board decisions fairly, deliberate carefully, and provide timely decisions.
- Develop a sound, consistent, well-reasoned administrative interpretation of the workers' compensation law for the guidance of insurers, employers, workers, and the Board.

#### **Key Component Challenges**

At the beginning of FY 08 the commission had a docket of 36 cases awaiting decision, more than double the preceding fiscal year which had 16. During FY 08 an additional 40 appeals were filed. Despite the number of cases handled, the commission ended FY 08 with 41 cases on the docket without final merit decisions, an increase of only 5 cases over last fiscal year. The commission continues to review and modify procedures as appropriate to ensure appellants receive a timely hearing.

## Significant Changes in Results to be Delivered in FY2010

No changes in results are anticipated.

## Major Component Accomplishments in 2008

During FY 08, 98% of open appeals had been heard within 12 months and 92% had been decided within 12 months, including appeals filed in FY 06/07.

The commission completed the process of establishing a regular volunteer summer law internship in cooperation with the Alaska Labor Relations Agency and increased the number of summer law interns to 2. The commission also began the process of obtaining a university law school sponsor for its semester externship program during FY 08. The externship will begin in January of FY 09.
