**Project Description/Justification:**

The Birchwood Airport Master Plan and Environmental Assessment (EA) has been ongoing for 5 years under several FAA grants. To date, a master plan, master development plan, draft EA, and associated archaeological report have been completed. In order that the airport be protected from incompatible land uses occurring around it, it is necessary to acquire land identified in the airport master plan for future development. In order to begin this acquisition, the EA must be finalized, and a Finding of No Significant Impact (FONSI) prepared. Additionally, the demand for ultralights and light sport aircraft has changed since the plan began. This demand needs to be assessed.
