Department priority programs define the three operational aspects of meeting our mission and cross all programs within the department.

**Maintenance & Operations of State Transportation Systems** is important to the safety of public use of the state's transportation systems; supports economic development in terms of travel industry, general public, and commercial vehicle transportation, etc.

**Measurement Standards/Commercial Vehicle Enforcement** reduces the risk of accidents or road damage from unsafe commercial vehicles and/or loads.

**Transportation & Facilities Construction Program** provides the planning and management of construction projects across the department. This includes major repair and rehabilitation of all transportation modes, and state owned facilities, operated and maintained by the State of Alaska.

#### Maintenance & Operations of State Transportation Systems



The department's target of increasing by 15 centerline miles per year the national highway system (NHS) non-intermodal roads that meet current standards was exceeded this past year. In FFY2009, 1,521 miles of the State's NHS routes meet national standards, which is an increase of 75 miles over FFY2008.

- The department uses a 3-year moving average to track highway transportation safety through traffic fatalities. In 2009, this average was 4.41%, lower than the previous 3-year moving average. Alaska experienced 1.30 traffic fatalities per 100 million VMT in 2009. This compares to the early national estimate of 1.16 fatalities per 100 million VMT, which is the lowest on record at the national level.
- The department strives to reduce the number of occupational injuries and illnesses in the department to less than the national average. For 2008 the department's overall incident rate was 3.5, which is slightly higher than the 2008 national average of 3.4.
- The number of airports that were closed due to seasonally soft runway conditions or other issues decreased by three (3) from FFY2009 to FFY2010. This exceeded the target of reducing seasonally closed airports by one per year. Additionally from FFY2004 to FFY2010 there has been a reduction of closures from 23 to 8.
- Decreasing the deck area of bridges classified by the Federal Highway Administration (FHWA) as structurally deficient or functionally obsolete is calculated using a five year average. In 2009, the five year average for the deck area of all bridges classified as structurally deficient or functionally obsolete decreased by 1.9%, compared to a decrease of 1.7% for the five year average reported in the prior year.
- On-time Alaska Marine Highway System vessel departures in 2009 were 92% which is an improvement over the 88% previous 3-year average and well above the industry standard of 75.1%.
- In FY2009, Alaska Marine Highway System Vessel Car Deck Capacity Utilization rose by 1%, from 57% to 58%, and for the 4th year in a row, meeting the target of a 1% increase per year.
- The rural airport revenues collected in FY2010 increased by 4.45% from the prior fiscal year.
- During FFY2010, one runway lighting project was significantly completed, which meets the goal of increasing the number of runways with permanent lighting in remote communities by one per year. In addition, in 2010, the department received Airport Improvement Project funding for two (2) runway lighting projects.

#### **Measurement Standards & Commercial Vehicle Enforcement**

99.3% of the commercial motor vehicles weighed at fixed and mobile sites in FFY 2010 to date, were weight compliant, meeting the department's goal of 99%.

#### **Transportation & Facilities Construction Program**

The percentage of administrative and engineering costs compared to total project costs decreased to 19.6% in FFY2009, well within the department's target of 30%, and slightly below FFY2008.

#### **Major Activities to Advance Strategies**

- Design roads to appropriate department standards
- Biennial bridge inspections
- Collect ride quality and rut data for both highway and airport pavement preservation
- Conduct survey every other year of public satisfaction with department services

- Partner with the Department of Labor, Occupational Safety to audit department programs and identify areas for improvement
- Design, procure and employ replacement vessels
  - Optimize AMHS schedules

#### **Key Department Challenges**

Key issues in the department are the uncertainty and timing of adequate funding levels to meet the transportation needs of Alaskans; the department's capability to obligate capital projects in a timely manner and the allocation of federal construction funds; growth and redevelopment of the Anchorage and Fairbanks International Airports; meeting security needs of all transportation modes; and changes in the composition of the Alaska Marine Highway System.

Key issues also include meeting the challenge to maintain a positive and productive work environment, facilitating meaningful human resource development, and ensuring high levels of responsiveness to the general public.

The department continues to be faced with the significant challenge of replacing its aging workforce as large numbers of employees are reaching, or are about to reach, retirement age. Private sector competition and national shortages of qualified and experienced engineers, right-of-way agents, surveyors, environmental analysts, skilled heavy equipment operators, and program managers are presenting us with major employee retention and replacement issues for the near future.

Program and administrative support continues to analyze services provided in an effort to find the most efficient and effective methods of service delivery, especially in light of the increased workloads placed on department staff as a result of increased reporting and compliance requirements from both the federal government and other state agencies.

Cost of doing business has increased within state government due to increased core service chargeback rates and costs related to employee merit and service step increases that agencies absorb within their existing budgets. Increased contractual and travel costs continue to edge their way up and are generally absorbed within the organization's existing budget, but the cumulative impact is being felt.

#### **Maintenance & Operations of State Transportation Systems**

Continued changes in the existing federal highway program which result in less flexibility in the use of highway funds, new safety programs, increased public involvement in the planning process, emphasis on reducing green house gases, and extensive Federal Highway Administration (FHWA) oversight of state DOT's environmental and financial activities make delivery of our program problematic. Because of the instability of the Federal Highway Trust Fund and the increasing difficulties in implementing the federal program, the department will continue to investigate a state funded transportation program.

Increased oversight and regulatory requirements from federal agencies have increased the cost of doing business and the amount of work required by department staff, i.e. Environmental Protection Agency (EPA) storm water regulatory compliance. The State entered into Consent Decree with the US Department of Justice and the EPA that requires more reporting and oversight of construction and maintenance activities. Additional staff resources are required to document and report on activities where storm water runoff could impact waters of the US. Training of all state and contractor personnel is now mandatory. The department staffing levels have not grown relevant to the added level of maintenance and compliance requirements.

Protecting Alaska's investment in its transportation infrastructure is a priority. The state's investments in facilities, roads, harbors and airports are eroding each year due to insufficient preventative maintenance. As the transportation infrastructure continues to age, we are faced with an ever-increasing list of deferred maintenance work, with an estimated cost of over \$740 million. Other demands include increases in the cost of labor, materials, electricity and fuel; cost of maintaining new infrastructure such as airport and highway lighting systems and highway traffic signals; and finally, the increasing burden of new laws and regulations.

Shifts in weather patterns are having a detrimental effect on infrastructure in the state. Fall storms continue to wreak havoc on airports, roads and buildings in western Alaska causing millions of dollars in damages. In Interior Alaska storm intensity and rainfall amounts are also damaging highway and roads, isolating communities and impacting commerce. Warmer weather trends are causing thawing of permafrost. This is resulting in pavement failure and ground deformation on roadways and airports increasing the deferred maintenance backlog.

The biggest challenge facing the Alaska Marine Highway System is the implementation of a replacement plan for its aging fleet. Of the 11 vessel fleet, which is comprised of 6 main-line vessels and 5 feeder vessels, 4 of the mainliners are over 45 years old and are rapidly reaching the end of their useful lives. With replacement vessels requiring up to 5 years for construction once funding is in place the system is approaching a very critical period.

One of DOT&PF's greatest challenges is maintaining the current level of service at the International Airports. It is critical to maintain existing revenues and to generate new revenue opportunities that are dependent upon aircraft activity. This is difficult in light of the severe economic downturn and continued bankruptcies and consolidations in the air carrier industry. Global air transport opportunities will continue to change as economic and political conditions change in China, Asia Major, Russia, and central Asia.

The federal aviation program has increased steadily since Federal Fiscal Year (FFY) 1999. The increase in grant funds has expanded airports around the state, making them safer for the traveling public and putting a larger burden on maintenance and operations. Project delivery including environmental permitting, right-of-way, design and engineering has received greater pressure from this increasing program. The department will maximize the amount of federal Airport Improvement Program funding available and ensure it is used to save lives, improve mobility and increase private investment.

#### **Measurement Standards & Commercial Vehicle Enforcement**

Motor Carrier Safety Assistance Program (MCSAP)/New Entrant Program Financial and Regulatory Review: 49 CFR 350.201(a) requires that States be compatible with adoption and enforcement of Federal Motor Carrier Safety Regulations (FMCSR's) and Hazardous Material Regulations (HMR). Changes to avoid loss of Federal Motor Carrier Safety Administration (FMCSA) and Federal Highway Administration (FHWA) funding are needed.

#### **Transportation & Facilities Construction Program**

2009 and 2010 were the years of the American Recovery and Reinvestment Act (ARRA). It provided both challenges and opportunities. ARRA introduced tight and challenging deadlines with no allowance for funding ongoing priority projects with longer development timelines. ARRA brought with it increased federal involvement and scrutiny of project development process leading to the renegotiation and tightening of the Federal Highway Administration /Alaska Department of Transportation project oversight agreement.

#### Significant Changes in Results to be Delivered in FY2012

The Department's FY12 operating budget includes:

- \$4.8 million for maintaining service levels primarily in the area of state equipment rate increases and accumulated shortfalls:
- Net increase of \$4.6 million for increased services primarily for the Alaska Marine Highway System (AMHS) including a new AMHS express route from Bellingham to Whittier;
- \$187.5 related to inflationary costs and mandatory/regulatory requirements; and
- Approximately \$10.5 million for Department-wide salary increases related to collective bargaining unit agreements.

#### **Major Department Accomplishments in 2010**

Maintenance & Operations of State Transportation Systems

- Performed 145 airport safety inspections.
- Profiled 3,476 miles of roadway to determine the pavement condition as part of our Pavement Management System.
- Issued 18,615 oversize/overweight commercial vehicle permits.
- Performed 484 routine bridge inspections (using state personnel), 77 fracture critical and special inspections (using state and contracted personnel), and 14 underwater dive inspections (using contracted personnel).
- Maintenance and Operations crews covered 1,501,477 linear feet of highways with surface crack seal treatment or re-leveling depressed roadway surfaces by "banding".
- Obligated an additional \$90M in project funding in FY10 over FY09 level.
- Obligated final 30% of ARRA funds in FY10.
- AMHS vessels responded to and assisted 16 distressed mariners from floundering/sinking vessels.
- The Alaska Marine Highway System schedule was produced early to meet the needs of the traveling public.
- Broke ground for the Lake Otis Parkway/Tudor Road intersection improvement project. This is the third major
  project within the last four years targeting improved traffic movement between south Anchorage and Midtown.
- The Ted Stevens Anchorage International Airport was recognized by Air Cargo World as North America's second top aviation cargo facility.
- The Fairbanks International Airport Terminal Development Project was completed and the new passenger terminal building has been turned over to the Airport.
- Maintained the International Safety Management Code program certification required for AMHS vessels to visit Canadian ports. AMHS is the only U.S. flag, vehicle-passenger vessel fleet with overnight accommodations to have earned this certification. This certification has become the safety standard for the entire AMHS fleet.
- Emphasized safety awareness through greater communication with the public through various forms of media (public exhibits, workshops, newspaper advertisements). The department entered into agreements with local police departments for officer presence at construction sites during peak traffic hours, enforcing compliance with construction zone speed limits.
- Performed repairs on 20 bridges throughout the Northern Region and cleaned and/or inspected another 11 bridges, four of them in the Southeast Region at the request of Bridge Design.
- Completed the construction of a \$17 million joint-use dock in Gustavus, which made possible the community's first service by AMHS.

#### Measurement Standards & Commercial Vehicle Enforcement

• Completed 7,204 commercial vehicle inspections during FFY10. Recorded inspections include 11,654 Commercial Vehicle Enforcement violations for unsafe, overweight, or un-permitted vehicles and unsafe or unqualified drivers, etc.

#### Transportation & Facilities Construction Program

- Total ARRA funding obligated to-date is approximately \$261 million.
- Obligated approximately \$178.5 in ARRA highway infrastructure funds.
- Obligated approximately \$9.1 million in ARRA grants for transit projects.
- Obligated approximately \$73.4 million in ARRA grants for Aviation projects.
- Repaved approximately 88 lane miles on the Glen Highway between the MatSu valley and Anchorage making for a smoother safer commute.
- Paved 56.4 lane miles of gravel roads.
- Repayed 282.3 lane miles of roads.
- Reconstructed 31.7 lane miles of roads.
- Built 1.5 lane miles of new roads.
