## Component: Fairbanks Organized Research

## Contribution to Department's Mission

The University of Alaska Fairbanks (UAF), the nation's northernmost Land, Sea, and Space Grant university and international research center, advances and disseminates knowledge through teaching, research, and public service with an emphasis on Alaska, the circumpolar North, and their diverse peoples. UAF - America's arctic university promotes academic excellence, student success and lifelong learning.

## Core Services

- $\quad$ Serves as the research campus for the University of Alaska system, through the activities of its component research institutes, centers, laboratories and related research facilities, making significant contributions to basic and applied science and engineering on state, national and international levels.
- Assists natural resource managers, develops understanding of natural phenomena, preserves, interprets and disseminates cultural knowledge, and contributes to improved engineering of northern roads, airports, structures, and other facilities.
- Extramural and state support funded $\$ 148$ million in research during the past fiscal year, and UAF is one of the top 100 research institutions in funding by the National Science Foundation.

## Key Component Challenges

Challenge 1: Modern laboratory facilities are needed for biomedical and life sciences research. The Life Sciences Classroom and Laboratory Building is essential, as well as sufficient funding for renovation and refurbishment.

Challenge 2: Energy and Engineering research facilities are needed beyond what the Energy Technology Building

under construction will provide.
Challenge 3: Several major grants and contracts are in jeopardy, totaling more than \$25M in annual research funding. This includes all of the ARRA funding, since the stimulus is by design temporary. Intense effort will be needed to replace this funding.

## Arctic Region Supercomputing Center (ARSC):

Challenge 1: State/UA/UAF commitment to fund computational research and high-performance computing in areas of high priority to the University and to the State of Alaska: climate change, atmospheric sciences, and fisheries and ocean sciences

Challenge 2: Secure external funding to support and acquire high-performance computing resources and cyber infrastructure needed to sustain UAF's computational science and research activities

Challenge 3: Facilitate continued growth of a faculty and student body able to more effectively use and employ computational science tools to advance research and discovery at UAF in areas of high priority to the University and to the State of Alaska

## Geophysical Institute (GI):

Challenge 1: Find alternative funds to offset the expected further UAF withholding and the loss of American Reinvestment and Recovery Act (ARRA) funds. This will be necessary to avoid loss of research business due to loss of Fund 1 resources.

Challenge 2: Develop plans to sustain faculty numbers in the face of four or five more retirements of senior faculty in the next few years.

Challenge 3: Maintain Poker Flat Research Range on track to develop a multi-faceted aerospace research and service center combining rocket launching and unmanned aerial system activities.

## Institute of Arctic Biology (IAB):

Challenge 1: Secure funding for the Life Sciences Building to allow continued growth and efficiencies of programs in biomedical and health sciences and climate change research.

Challenge 2: Recruit the best candidates to fulfill the current and anticipated faculty vacancies in IAB.
Challenge 3: Secure necessary start-up and negotiate funding that will lead to the best candidates accepting offers to fulfill current and anticipated faculty vacancies in IAB.

## International Arctic Research Center (IARC):

Challenge 1: The loss of senior staff members remains a serious threat to IARC. This is directly related to budget issues, as faculty appointments do require some stable support to guarantee a position for several years until the researcher is able to become self-sustaining.

Challenge 2: IARC is losing its large institutional grant support, which primarily funds its research faculty. IARC's NSF Cooperative Agreement will end June 30, 2011. Our JAXA agreement will likely continue at the present level for the next three years. The JAMSTEC agreement will likely decrease from $\$ 3$ million per year to $\$ 1$ million per year over the next five years.

## Significant Changes in Results to be Delivered in FY2012

Provide bridge funding to buffer the probable loss of Department of Defense funding for high performance computing.
Pay down revenue bond debt incurred in building research facilities.
Purchase items of major research instrumentation from the capital equipment list in the 6-year Capital Improvement Plan.

## Arctic Region Supercomputing Center ARSC:

Fund academic, scientific high-performance computing at UAF in support of research computationally intensive investigations in areas of high-priority to Alaska and the people of the Far North, including climate modeling, atmospheric science and ocean science. Institutions with academic supercomputing centers provide a competitive edge when it comes to recruiting top-notch faculty and students. According to the National Science Foundation's report "Cyberinfrastructure Vision for 21st Century Discovery," increasing access to supercomputers is crucial to keeping U.S. research competitive.

Reinstate full funding to support summer undergraduate research program in computational science
Support the Chinese Scholars Program in ARSC/UAF/UA disciplines of interest

## Institute of Arctic Biology (IAB:

IAB would use unanticipated funds to increase and improve our negotiating position for the 10 current and anticipated faculty vacancies.

## International Arctic Research Center IARC:

A new long-term monitoring station has been installed at Poker Flat Research Range. We need additional instrumentation added to this station, particularly sensors for eddy covariance and methane fluxes.

## Major Component Accomplishments in 2010

## Teaching, Research and Public Service:

Research expenditures, augmented by American Recovery and Reinvestment Act (ARRA) funds, were at an all-time high of $\$ 118 \mathrm{M}$.

The Alaska IDeA Network of Biomedical Research Excellence, or INBRE, received a five-year, \$17.7 million NIH grant.

The $\$ 150$ million in construction funding for the R/V Sikuliaq was the National Science Foundation's largest ARRA award.

UAF received $\$ 7.4$ million in ARRA funding from the National Institutes of Health to build research facilities for the Center for Alaska Native Health Research.

A $\$ 6$ million National Science Foundation grant to UAF and the University of Hawaii will support the Pacific Area Climate Modeling and Analysis Network.

In November 2009 scienceWATCH (http://sciencewatch.com/ana/st/climate/institution/) ranked UAF climate research 11th in the world (and 4th among US universities) in terms of the number of citations of climate research publications from UAF. From 1999 to 2009 UAF researchers had 347 climate-related scientific publications and 8098 citations of those publications.

## Arctic Region Supercomputing Center (ARSC):

A six-million dollar National Science Foundation grant to UAF and the University of Hawaii in the fall of 2009 to support the Pacific Area Climate Modeling and Analysis Network (PACMAN) provided the funds for ARSC to procure and install new supercomputing resources for use solely by the university community. The new supercomputer is named Pacman and will be used to investigate the effect of climate change on freshwater resources in Alaska and Hawaii.

ARSC hosted a series of 11 topical sessions focusing on the current state of computational research activities at the University of Alaska Fairbanks Feb. 15-26, 2010. More than 50 principal investigators representing a wide range of scientific disciplines met with colleagues at UAF who use supercomputers as an essential tool in conducting research. The forum provided an opportunity for PIs to review and discuss the potential for future cross-disciplinary computational science research in the fields of climate, tsunami, physics and chemistry.

ARSC undergraduate interns Jose Antonio Figueroa and Vahid Ajimine are two of only four students selected from a national field of high-performance computing scholars recognized nationwide at a June 2010 conference sponsored by the Department of Defense High Performance Computing Modernization Program (HPCMP) in Illinois.

High Performance Computing (HPC) Mass Storage Specialist Gene McGill has been tapped to lead a national effort on behalf of the DoD High Performance Computing Modernization Program to address growing concerns of managing, archiving and quickly accessing an ever-growing amount of potentially confidentially and often irreplaceable data. McGill will oversee the Storage Initiative for all six DoD Supercomputing Resource Centers in the country.

HPC Systems Analyst Liam Forbes (UAF '95, '98) was elected to the position of Board Secretary for the international Cray User Group at their meeting in Edinburgh, Scotland May 2010.

HPC Systems Analyst Melinda Shore was awarded U.S. Patent 7680104 on March 16, 2010 for technology allowing embedded IP addresses to be represented as tags.

## Geophysical Institute (GI):

A program was developed that utilizes a computer code simulating non-EPA-compliant winter conditions in temperature inversions that will enable scientifically-based planning to minimize the build-up of harmful PM2.5 pollution (http://www.mmm.ucar.edu/wrf/users/workshops/WS2009/abstracts/5A-07.pdf).

A successful mission was completed in support of the Emergency Response Exercise in Anchorage using the GI unmanned aerial vehicle equipped with high resolution video cameras at visible and infrared wavelengths (http://www.dvidshub.net/news/48753/alaska-hosts-vigilant-guard-exercise-week).

A new GI/UAF rocket program successfully launched at Poker Flat in March 2010 providing 3-dimensional wind profiling at heights of 100 miles.

Hajo Eicken was selected to lead the international Study of Environmental Arctic Change (SEARCH) program (http://www.arcus.org/SEARCH/) that is strongly endorsed by circumpolar nations.

Steve McNutt completed two 4-year terms as general secretary of the International Association for Volcanism and Chemistry of the Earth's Interior.

Jeff Freymueller completed his term as American Geophysical Union Chair of the Geodesy Section.

## Institute of Arctic Biology (IAB):

The Bonanza Creek Long-Term Ecological Research (LTER) grant, "Regional Consequences of Changing ClimateDisturbance Interactions for the Resilience of Alaska's Boreal Forest," was renewed in the amount of \$5,640,000.

Toolik Field Station received a 5 million dollar American Reinvestment and Recovery Act (ARRA -stimulus) award from the National Science Foundation for design and construction of a new $6,000 \mathrm{sq} \mathrm{ft}$ dining and kitchen facility.

Terry Chapin, elected President of the Ecological Society of America, the nation's foremost professional society in ecological sciences.

Perry Barboza, recipient of the Wildlife Publication Award - Outstanding Book Category for Integrative Wildlife Nutrition, published in 2009.

## International Arctic Research Center (IARC):

IARC researchers Natalia Shakhova and Igor Semelitov, in partnership with scientists from the Far East Branch of the Russian Academy of Science, demonstrated that the flux of methane from the Laptev Sea area just off the Lena Delta was as great in magnitude as the rest of the world's oceans combined. IARC organized the arctic research community in writing a Science Plan to develop Arctic System Modeling. This
required three international workshops and well over 100 contributors and reviewers, but the final plan has been widely and warmly welcomed by researchers and agency program managers. See http://www.iarc.uaf.edu/publications/reports/IARCTP10-0001.pdf

The Louis Agassiz Medal was awarded by the European Geosciences Union to Hajo Eicken for his outstanding contribution to the study of the physical and biological properties of sea ice through a combination of novel experimental techniques and theory.

Graduate student Oceana Francis was named Young Engineer of the Year by the Alaska Society of Professional Engineers. Oceana serves as VP for the Fairbanks Chapter of the American Society of Civil Engineers and is also involved with the American Indian Science and Engineering Society, and the Alaska Native Science and Engineering Program. She is actively involved in bringing science and engineering together.

Director Larry Hinzman was selected to present the Nye Lecture at the 2009 American Geophysical Union meeting.

## College of Engineering (CEM)/Institute of Northern Engineering(INE):

For FY10, INE witnessed an increase of $3 \%$ in research funding over FY09. This brings INE to $21 \%$ growth (in total expenditures) since 2006.

By permanently funding the Alaska Center for Energy and Power (ACEP), the State Legislature recognized that ACEP is a key component in the development of the State's energy policy and meeting the needs for rural power and economic development.

## College of Natural Sciences and Mathematics (CNSM):

The Engineering, Science and Technology Experiment Station (ESTES) has almost \$2M in grant-funded research expenditures and accrued more than $\$ 350,000$ in Indirect Cost Recovery for UAF.

## School of Natural Resources and Agricultural Sciences (SNRAS):

Peony research leads to Alaska Peony Growers Association first entry into national and international markets in the 2010 season

University of Alaska Museum of the North (UAMN):
The Collections departments hosted over 500 researchers during FY10.
