Contribution to Department's Mission

Incarcerate and supervise male and female, sentenced and unsentenced adult felons and misdemeanants that are committed to the custody of the department.

Recruit, hire and retain a workforce of well-trained officers to meet the challenge of facility standards and public protection.

Reduce the ongoing deterioration of the facility and backlog.

Assure that current department standards for security, safety and current correctional practices are adhered to.

Meet operational expectations while striving to remain within fiscal parameters.

Maintain and expand a viable and successful electronic monitoring program while assuring public safety.

Provide for timely and efficient screening and assessment of all inmates to allow appropriate placement, programming and transition to community supervision.

Inmate population continues to drive exceptional transportation and medical costs in an attempt to assure appropriate prisoner care and institutional safety. The increases to inmate populations continue to create numerous logistical and financial challenges.

Significant Changes in Results to be Delivered in FY2013

No changes in results delivered.

Major Component Accomplishments in 2011

Conducted the annual four-day Kairos Prison Ministry Program for offenders. This program was followed by an Instructional Reunion and weekly meetings for offenders who participated.

The Sentenced Facility held one potlatch, hosting outside speakers, native elders, native dance group members and guests.

Wildwood Correctional Center continues to provide evidence-based programming in the areas of education, vocation, substance abuse treatment, re-entry, parenting and criminal thinking.

In cooperation with local faith-based volunteers, a new program was developed giving female offenders the opportunity to interact weekly with female volunteers inside the dorms, receiving counseling and completing small craft projects.

Continued operations in a 24 bed Life Success Substance Abuse Treatment Program Level II alcoholism and drug abuse treatment program for sentenced offenders.

Continued a faith-based program facilitated by Alpha USA, Division of Prisons & Re-Entry, a non-profit agency dedicated to faith-based re-entry programs for sentenced offenders.

Expanded community road cleanup projects and assisted the City of Kenai with local park cleanup and brush removal.

Re-arranged prisoner housing assignments at Wildwood Pre-trial to accommodate a large increase of female offenders and eliminate the need to house prisoners in the gymnasium.

Wildwood Correctional Center provided in-house training to staff in the areas of fire, life and safety and institutional protocols. Staff completed approximately 14 hours of training per employee.
