Funding Details:

If the state funds are granted, Chugach Electric Association has committed to contribute \$200,000 of the cost of this project. The Municipality of Anchorage will contribute the \$300,000 estimated cost of adding lights on Dailey Avenue and Pacific View Drive, and putting Dailey plus Bree Avenue and Pacific View on load centers.

Detailed Project Description and Justification:

This project would replace 122 existing, older, high-pressure sodium streetlights in the Oceanview area of Anchorage with new, energy-efficient light-emiting-diode (LED) streetlights. As part of the project, approximately 13 LED streetlights would be added to illuminate two roads that currently have no streetlights. In total, 135 new lights are planned. Due to the energy efficiency and long life of the new lights, this project will provide benefits that will be shared by the neighborhood, Municipality and Chugach. Residents will see improved illumination for nighttime safety, the Municipality will pay lower lighting costs and Chugach will incur less maintenance expense. The Municipality has agreed to pay the cost to install the new lights where none exist on Dailey Avenue and Pacific View Drive and to convert the lights on Bree Avenue plus Dailey and Pacific View to metered load centers. The other lights will remain Chugach's and will be billed to the MOA under the appropriate tariff for LED streetlights. Chugach proposes the requested grant flow through the Municipality of Anchorage. Chugach and the MOA will develop a project agreement to manage the grant funds in response to project activities. The requested grant includes a 5 percent MOA admin fee of 37,500.

Project Timeline:

If grant funds are approved in 2013, the conversion of existing street lights not destined for load centers will will be done in 2013. The load center projects may not be completed until 2014.
