Boys & Girls Clubs is a private non-profit corporation in its 46th year of service to Alaskan youth. Boys & Girls Clubs is affiliated with the national organization Boys & Girls Clubs of America and share their commitment to help youth of all backgrounds develop the qualities

needed to become responsible citizens and leaders. Boys & Girls Clubs' mission is to empower and inspire the diverse youth of Alaska to realize their full potential by offering them hope, opportunity, and a safe environment in which to grow.

Forty-two Clubs serve over 12,000 young Alaskans each year, and Clubs welcome thousands of visiting families and youth at our community events and Clubhouse activities. Each day, Boys & Girls Clubs help our state's youth by:

- o Mentoring children during the peak juvenile crime hours of 3:00 to 6:00 p.m.;

Nearly indestructible Moduform tables and equally strong chairs will replace worn and broken tables and chairs in the Club and Community Center. In the gamesroom -- where 900 youth members are served annually -- will be two new commercial grade pool tables and two commercial grade air hockey tables.

In the cafeteria area of the Club -- where Children's Meal Mission serves hot meals every day to children -- three new folding cafeteria-style tables will be added.

The community center will also have use of 30 new commercial-grade folding tables and 100 folding chairs. Storage areas will be refurbished with gorilla racks to aid in keeping this busy Club and Community Center neat and clean.
