*Funding Details:**Total Cost of Project: \$250,000 in FY14.***Detailed Project Description and Justification:**

Salcha Fire & Rescue requests \$250,000 for construction of two additional warm bays for the Salcha Fire and Rescue Station 1. Salcha Fire and Rescue is a 501C4 volunteer fire department providing 24 hour professional emergency services to the greater Salcha area along the Richardson Highway from Eielson Air Force Base to Mile Post 294.5, an area over 45 miles long.

Currently one 500-gallon fire engine is decommissioned due to lack of warm apparatus bay space. It is critical to obtain this space in order to achieve an ISO 8 rating. This project enhances response capability by providing heated apparatus storage on site for station #1. It will also provide much needed training classroom space and a small office, removing it from the existing apparatus bay. In-kind support is provided for oversight and to assist in construction of the building.

Station 1 is the staging area for all 911 calls in the northern section of Salcha.



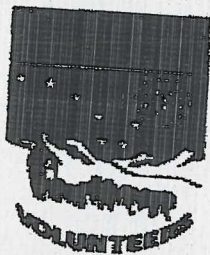
