Denali Education Center, a nonprofit organization, is seeking \$109,000 in state funds to build restrooms and upgrade facilities for its community building, which primarily serves elderly clientele. The building hosts events and functions during the summer months, educating tourists to Denali National Park and is a favorite gathering place for Denali Borough residents and visitors. The building is currently serviced by two portable toilets. All patrons, especially elderly guests, are reticent to use these and are often forced to walk 300 yards to the neighboring lodge for relief. Having running water with sanitary bathroom facilities will allow them to pursue new business with tour operators that wouldn't consider their educational programs due to the lack of facilities. Funding will be used to build restrooms (with corresponding septic) and to

Detail About Funds Already Secured: DEC has \$100,200 allocated in a savings account for this project consisting of \$45,000 of program revenue over the past two years; \$44,200 in private donations from an annual community fundraising auction; and \$11,000 from charitable gifts to the organization over the past two years. We have invested in a strategic plan for the organization (\$5000) and have received pro-bono services from the Alaska Chapter of the American Society of Landscape Architects (ASLA) for a Campus Master Plan (\$10,500). Our project deficit will be paid for through fundraising efforts in 2013.

Brief Description

Denali Education Center is seeking state funds to build public restrooms (with septic and water systems to service them) for its community building, the Charles Sheldon Center. Funds will also be used to finish the floor, fix the roof, and retrofit the building to separate staff offices and facilities from public space.

Detailed Project Description

Denali Education Center (DEC) completed a strategic plan with the facilitation of Agnew::Beck Consulting in 2011. Business priorities and sustainable solutions for our future were mapped at that time.

We applied for Rasmuson Foundation's Pre-Development program in February of 2012, but due to overwhelming demand, have yet to be accepted into the program. In lieu of this support, we forged forward with the assistance of our board of directors and the Alaska Chapter of the American Society of Landscape Architects in the late summer of 2012. These sessions produced a comprehensive, phased plan to upgrade our facilities. From this, we have begun the challenge of bringing our public spaces in line with general visitor expectations.



One of our strategic plan priorities is to diversify our revenue stream and attract new business. We have identified the need to upgrade our public spaces as a first step in this plan. Our desire is to build bathrooms for the place where our visitors make their "first impression" at the heart of DEC's campus, the Charles Sheldon Center.

The Charles Sheldon Center was built by the community with over 4,000 hours of volunteer labor. It is a visually pleasing structure with post-and-beam construction, stained glass windows, and many other artistic attributes. Since its construction in 1998, it has served our organization and the community well, hosting over 3,000 people every year. Our clientele are primarily elders and the lack of sanitary facilities hampers our ability to attract new business and threatens the relationship we have with long term clients as their customers demand better services during their visit.



Visitors must use portable toilets as sanitary facilities. This not only limits the scope of offerings the organization can successfully attract, the annual portable toilet rental fees are not cost effective.

The floor covering is simply painted subfloor plywood and though still in reasonably good condition, should be finished for aesthetic reasons as well as safety and long-term preservation of the facility.

In the last several years, the roof has developed a persistent leak. We have attempted to repair the leak by replacing the roof screws and applying heavy amounts of silicone, but after seeking advice of a local contractor; have determined that there is insufficient overlap of the tin and that we very likely have sustained water damage that should be properly repaired.

Additionally, as the organization has grown, it has become clear that retrofits are necessary to restructure and differentiate staff offices and facilities from public space. Remodeling our existing buildings and upgrading utilities will increase the organization's capacity for programming, keeping the Charles Sheldon Center the beloved community center that it has been since constructed.

Project Description Detail

Denali Education Center is making a capital project request of \$109,000 for necessary upgrades including public restrooms to its vital community building, the Charles Sheldon Center, in Denali Park, Alaska.

How funds will be/have been used:

- Strategic Plan (done): \$5,000
- Facility Assessment (done): \$10,500
- Site engineering: \$19,000
- Site prep and landscaping: \$13,500
- Septic system: \$58,200
- Replace and repair roof: \$15,800
- Level floor and install flooring: \$18,700
- Construction of bathrooms: \$54,500
- Remodel of existing facilities: \$69,000

Local engineers and contractors will be hired to design and construct the new restroom facilities, and make all necessary improvements and repairs. Weather conditions and previously scheduled events in the Sheldon Center will dictate the schedule.

About the Denali Education Center's Charles Sheldon Center

At its heart, the Denali Education Center features the Charles Sheldon Center - a facility that was built over a period of three years, beginning in 1995 and finishing with a grand opening celebration in 1998. The community building was primarily constructed with donated materials, from the logs that form its post-and-beam framework, to the electrical wire and switches, and even the tin roofing. Over 4,000 volunteer hours were logged during its construction; community members helped with all aspects of building from peeling logs to digging holes to raising the roof (an event that drew almost 100 volunteers in 1996). **The building is the heart of the organization because of the investment made by the local community.**

Since its completion, the building has seen incredible success – thousands of people utilize the Charles Sheldon Center each season. From lectures to concerts and weddings to memorial services, a wide variety of events are hosted here. Local citizens are encouraged to organize and host their own events which range from yoga to board meetings for other nonprofits. Denali Education Center is non-advocacy, providing a venue for all to present and consider both preservation and use of Alaska's resources.

DEC has recently received grant support for capital improvements to this facility. In 2011 DEC received a \$25,000 Tier 1 grant from the Rasmuson Foundation to build new stairs and porch for our administrative office and to remodel the two offices within in the Charles Sheldon Center.

About Denali Education Center

Founded in 1989, Denali Education Center is a partner of Denali National Park and Preserve. We are located in the Denali Borough on 10 acres along the park's eastern boundary. *Denali Education Center's mission is to foster appreciation and understanding of Denali through informative and inspiring programs.* Our primary clientele are senior citizens who come to us through the Road Scholar program and several Alaskan tour operators who bring their clients to us for our expert educational presentations.

The Denali Education Center also serves the community with a variety of programs. Favorites include *Denali Discovery Camp* for children entering 1st through 8th grade; *Denali Backcountry Adventures* for teens of high school age; the *Scott Menke Summit Scholarship* that benefits graduating Denali Borough students; *Community Series* programs that feature lecturers, artists, musicians, crafts and social gatherings such as yoga classes, square dancing, a golf tournament, and our annual Auction. We also serve the greater good of Alaska's children through the *WILD About Denali* program for disadvantaged youth and *Denali Bug Camp* for budding entomologists across the state of Alaska.

Denali Education Center also helps Denali National Park and Preserve fulfill its mission. In addition to teaching about the park and its environs, DEC supports research in the park with the *Discover Denali Research Fellowship*, contributing over \$20,000 annually.

The Denali Education Center is a local business, important to the local economy. We have longevity and are fiscally stable, responsible with our funds, and thrifty when it comes to spending. State funding for this project has wide support and will have a lasting impact on the residents of Denali Borough, and the state of Alaska.

Community Support

This particular project has received wide community support as evidenced by the breadth of letters received by Representative Guttenberg and Senator Hoffman's offices. Although Denali Education Center is primarily funded through revenue earned from residential programs, we also enjoy strong financial and in-kind support from our community.

Denali's "community" extends far beyond the borders of our borough. Though a hub for tourism in the state, Denali's local businesses must take their dollars to our major cities for supplies and services. We view this as an advantage, allowing us to network with a broader community. These relationships become particularly important for our annual fundraising auction. This event draws as many as 600 participants and raises roughly \$50,000 annually. Thousands of donations for goods and services have been given by individuals and businesses from around the state and across the country in support of this event. It is Denali's largest community event, bringing people together who plan for and look forward to this gathering each year.

Our youth programs benefit greatly from an annual golf tournament, the Healy Tundra Challenge. All proceeds go to the Scott Menke Memorial Fund; created to honor the life and spirit of a vibrant young community member whose life was cut short. This fundraiser packs the Black Diamond Golf course each year, with Black Diamond donating the use of the entire course. The event raises over \$10,000 each year and funds scholarships for Denali Borough students, and helps offset expenses for our youth camps.

Community support is also demonstrated by the strong volunteer effort that citizens continue to contribute to the organization's grounds and buildings. Each year we host an official "Volunteer Day." Rotaract groups (young Rotarians associated with the University of Alaska) from both Fairbanks and Anchorage participate in our Volunteer Day each year. Volunteer Day draws an average 30 local area participants each year. Our community also contributes their time to provide human interest programs and hike with program participants, enhancing our guests' experience to Denali. Each year we log hundreds of volunteer hours.

DEC has received grant support for capital improvements and equipment upgrades from the Rasmuson Foundation over the last several years. We have also successfully obtained grants from the Usibelli Foundation, Fred Meyer Foundation, the Alaska Mental Health Trust Authority and many others in support of our organization.

We're pleased to report that our project was successful on every level. It was a community and group effort that re-affirmed the joys of living and working in such a caring place.



The biggest improvement was replacing the old porch on our combined dining and classroom facility, Riverside Hall. A dedicated local board member donated his time to remove the existing rotting porch and a few trees that were in the way of the new construction site.



A local excavating contractor working at a nearby site brought loads of fill to smooth out the building site.

When he heard that we were planning to rake and try to compact it by hand, he offered his heavy equipment to prepare us a proper building site free of charge.



The deck was completed before our first group of the season arrived, but the doors and windows were not yet replaced. I sat on our new porch watching guests go in for dinner one sunny evening. Each in turn would try slamming the old door a few times, but it was so warped, it would not latch. They were all very pleased when the doors and windows



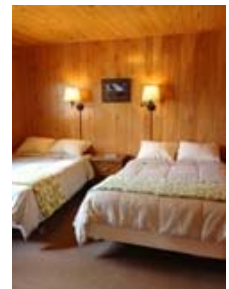
were replaced mid-week. They not only worked properly, but brightened the room immensely as well.

We also had a serious rain storm that first week the campus was open. The contractor had not yet replaced the roof screws, so (much to our horror) these guests also witnessed the leaks in the roof firsthand. After the deluge, all of the screws were replaced in an afternoon. The contractor gave us a large surplus of screws for future use and to fix leaks on our other buildings as well. Subsequent downpours let us know that the new screws work perfectly. On the last night of that first program, there was a round of applause from our guests for the new doors, windows and roof repairs.

We replaced all the old, heavy, torn and over-sized curtains in our guest rooms. The new window coverings arrived in plenty of time and were a snap to install. They look fabulous, are easily cleaned, and should last for many years. The supplier extended us a discount of \$1200.



We replaced all the bedding in each of our guest cabins. Some of the old bedding went to the Fairview Inn in Talkeetna, but the majority was received with tears of joy at the Fairbanks Rescue Mission. The new bedding has been a wonderful change and is much easier for our housekeepers to work with. Fred Meyer gave us a \$500 gift card to use towards its purchase.



At the close of the project, we've made improvements totaling nearly \$30,000; enjoyed nearly \$4000 in savings, discounts and donations; worked with some wonderful supporters and given back where we could. Thank you once again for your support.

2011 Denali Education Center Small Grant Report Narrative
for Rasmuson Grant 6000, *Furniture Facelift*

We had a very busy opening this year as we pushed to get all of the changes made for our desired improvements. Things couldn't have gone smoother and everything looks amazing!

As soon as we knew we were awarded the grant, we placed orders for the chairs and tables. We got chairs for our dining and lecture halls and opted to get additional chairs for all of our guest rooms to replace the twenty-year-old wooden chairs that were looking tired. One exciting turn of events is that we were able to re-purpose all of the chairs that we replaced! Our local community center took about 30 of our lecture hall chairs and some were given away to community members. We put up flyers in the post office and got a call from the Nenana public school. They wanted ALL of the remaining chairs for their assemblies and class rooms as they had a shortage when they had events. They are going to refinish the wooden chairs, and re-upholster and paint the lecture hall chairs as a school project and are thrilled with the donation!

Our first Road Scholar group on the residential campus had some returning participants from prior years. They immediately noticed the new chairs and tables and thanked us profusely for buying such comfortable chairs. They confided that they had discussed their concerns before coming back for a program because they dreaded the uncomfortable seating in our dining hall. We are so pleased to be improving our guests' experience.

We completely gutted our office to prepare for the modular furniture installation in early May. We patched and painted the walls, pulled up the old carpet and replaced it with carpet square tiles that were deeply discounted by a generous business in Fairbanks (a great connection made at Leadership Fairbanks classes through the chamber of commerce) and were ready to roll when Robin Smith and Eric McCallum arrived for the installation. Things went so well that we went forward and remodeled our seasonal office on the ground floor as well. It's been SO nice to have professional looking offices that have much better usable work space. We could never have done all of this without the effort of many volunteers who worked long hours to help make this happen.

The day after the furniture was installed, the materials were delivered for the stairs and the work began for removal and replacing them. In addition to the stairs, we had exterior siding installed over what was bare plywood. Volunteers stained the siding before it was installed and it looks beautiful. The old supports for the stairs were seriously rotted and it was a matter of time before they would have been too dangerous to use. The new stairs look incredible and really improve our image as a professional organization. Some of what was removed has been repurposed into other structures around our campus. The Rasmuson Foundation grant allowed us to make some long overdue changes and we are very grateful. We are inspired to continue with our improvements and thank the Rasmuson Foundation deeply for your generosity.







In its 23-year history, the organization has developed into an important community entity for the Denali Park Borough from Anderson to Cantwell. In addition, the organization serves the tourism industry – a business sector of vital importance to the local economy.

The Denali Education Center serves the community with a variety of programs, such as the Denali Discovery Camp for children entering 1st through 8th grade; Denali Backcountry Adventures for teens of high school age; the Scott Menke Summit Scholarship that benefits graduating Denali Borough students; Community Series programs that feature lecturers, artists, musicians, crafts and social gatherings.

The Denali Education Center serves the greater good of Alaska's children through its WILD About Denali program for disadvantaged youth and Denali Bug Camp for budding entomologists across the state of Alaska.

Denali Education Center is a local business, important to the local economy. Their participants book thousands of dollars in excursions with local purveyors. They require the same services as other businesses and are customers of businesses from Anchorage to Fairbanks.

Denali Education Center is a partner with the National Park Service and helps them to fulfill their mission. In addition to teaching about the park and its environs, they support research in the park with the Discover Denali Research Fellowship, contributing over \$20M annually.

Requested funds will be used to upgrade the heart of DEC's campus, the Charles Sheldon Center. The Charles Sheldon Center was built by the community with over 4,000 hours of volunteer labor. Since its completion in 1998, it has served the organization and the community well, hosting over 3,000 people every year. Due to the organization's success, upgrades are necessary.

Though visually pleasing with its post-and-beam construction, stained glass windows, and other artistic attributes, the building lacks several basic necessities such as a finished floor and plumbing. Visitors must use two portable toilets as sanitary facilities. This limits the scope of offerings the organization can successfully attract and is not cost effective as rental and maintenance of the portable toilets averages \$2,500 annually. The floor covering is simply painted subfloor plywood and though still in reasonably good condition, should be finished for aesthetic reasons as well as safety and long-term preservation of the facility. Additionally, as the organization has grown, it has become clear that retrofits are necessary to restructure and differentiate staff offices and facilities from public space. Remodeling the building and upgrading utilities will increase the organization's capacity for programming, keeping the Charles Sheldon Center the beloved community center that it has been since constructed.

State funds will be used to build public restrooms adjoining the Charles Sheldon Center with corresponding septic and water systems to service them. Funds will also be used to finish the floor and fix the roof, which has a chronic leak due to insufficient moisture barrier and overlap of the roofing tin. Finally, state funds will be put toward retrofitting the building to differentiate staff offices and facilities from public space.

Please support this wonderful organization and help them obtain this crucial financing.

Denali Citizens Council schedules educational forums at the Sheldon Center at least once or twice a year, hosting 50-75 people each time, but we are only one organization of many. The absence of restrooms in the building has been awkward for a space that otherwise is an optimal venue for us. While our forums are attended mostly by local residents and other Alaskans who shrug and adapt to the use of the portable toilets outside, it nonetheless would be much more healthy (given the constant volume of use) to have a real restroom facility. A significant portion of the building's use is for programs serving tourists from out-of-state who are likely put off by the absence of restroom facilities. These are folks who are bringing dollars into the local economy and contributing to local government revenue, so it is worth keeping them happy.

It is a beautiful building that appears very professionally finished, except for the notably unfinished floor and absence of restrooms. I am writing this letter to ask for your support of the Denali Education Center. I serve as a member of the Board of Directors and am passionate about this organization. We have submitted a request for funds from the 2013 State budget.

Since 1989, the Denali Education Center (DEC) has been a non-profit educational partner of Denali National Park and Preserve. DEC serves Alaska residents and visitors of all ages on their McKinley Village campus through day programs, youth programming, multi-day field trips, research grants, and special events.

In its 23-year history, the organization has developed into an important community entity for the Denali Park Borough from Anderson to Cantwell. In addition, the organization serves the tourism industry – a business sector of vital importance to the local economy.

Requested funds will be used to upgrade the heart of DEC's campus, the Charles Sheldon Center. **The Charles Sheldon Center was built by the community with over 4,000 hours of volunteer labor.** Since its completion in 1998, it has served the organization and the community well, hosting over 3,000 people every year. Due to the organization's success, upgrades are necessary.

Though visually pleasing with its post-and-beam construction, stained glass windows, and other artistic attributes, the building lacks several basic necessities such as a finished floor and plumbing. Visitors must use two portable toilets as sanitary facilities. This limits the scope of offerings the organization can successfully attract and is not cost effective as rental and maintenance of the portable toilets averages \$2,500 annually. The floor covering is simply painted subfloor plywood and though still in reasonably good condition, should be finished for aesthetic reasons as well as safety and long-term preservation of the facility. Additionally, as the organization has grown, it has become clear that retrofits are necessary to restructure and differentiate staff offices and facilities from public space. Remodeling the building and upgrading utilities will increase the organization's capacity for programming, keeping the Charles Sheldon Center the beloved community center that it has been since constructed.

State funds will be used to build public restrooms adjoining the Charles Sheldon Center with corresponding septic and water systems to service them. Funds will also be used to finish the floor and fix the roof, which has a chronic leak due to insufficient moisture barrier and overlap of the roofing tin. Finally, state funds will be put toward retrofitting the building to differentiate staff offices and facilities from public space.

I sincerely appreciate your consideration of our ask and hope that we can count on your support. The DEC is a well-respected organization in the Denali community and has many supporters throughout the State.

I'm writing in support of the Denali Education Center. In 2012, I made the trip of a lifetime to Alaska to spend the summer living in a rustic cabin on the Denali Education Center campus as the center's residential volunteer and doing my small part to aid the mission of the DEC: fostering appreciation of Denali through informative and inspiring programs. Through the DEC, people of all ages make a true connection to Denali through educational programs and cultural events.

The DEC is a place like none other. Built on the curve of a Nanana River oxbow, it's a scenic spot near the entrance to Denali National Park and surrounded by the gorgeous wilderness of Denali. The Charles Sheldon Center is the heart of the campus, and its tall ceilings and graceful stained glass make it a unique and wonderful place. It serves many purposes: A lecture hall, a gallery for local artists, a performance space for music and dance, a yoga studio, a wedding hall, and on at least one occasion, a warm place for a half dozen of our soaked and sleepy youth program kids in who'd gotten rained out.

But as lovely as the space is, it needs significant improvements. The only toilet facilities at the Center are port-a-potties, which was often an uncomfortable choice for all our guests, particularly young families, the elderly, the mobility impaired, and the gastrointestinally urgent. During events like concerts and instructor-led programs, the two port-a-potties had lines like a theme park ride. Flush toilets would allow the DEC to meet their current needs and expand their range of offerings in the future.

The floor and roof of the Sheldon Center also require improvements. Although the roof has been patched many times, it tends to drip here and there on rainy days. The floor is basic painted plywood, which peels and creaks. I've mopped the floor dozens of times, but I confess it really only looks good when it's dark. It's a temporary solution for this space, but it's time to make this improvement.

As a non-profit, the DEC runs on a modest budget and uses their funding wisely. After working closely with them for the full season and experiencing firsthand their commitment to their mission and the community, I am confident that new funding for these improvements would be well spent and make a big impact.

I am writing this letter in support of Denali Education Center's request to the Alaska State Legislation for financial aid to improve their educational facilities in the Denali National Park area.

The Denali Education Center has provided hands on classes, lectures and presentations on Denali National Park and the surrounding areas for over 20 years.

In the summer, one big focus for the center is offering a number of youth outdoor camps, some of them focusing on disadvantaged youths; all of them providing an opportunity for children from all over Alaska to study nature in real life and observe and record the ecosystem of the Alaska Range. The youths stay at the cabins at the education center and take their classes in the Charles Sheldon Center.

The Denali Foundation has also been the local host site for the Road Scholar Program (formerly known as Elderhostel) since the late 1980's. In the summer, these participants also stay at the cabins for about a week at a time and have classes in the Sheldon Center.

Even more significant, the Denali Education Center also provides a very important year round service focused on the local community—the Charles Sheldon Center offers a large, indoor space for community use. This center was built with volunteer labor, proving the support of the community for this facility. The Denali Education Center brings in both local instructors and instructors from other areas of Alaska to provide various evening classes on specific topics. The Center is also used for social events and physical activities such as yoga classes, square dancing, band concerts, etc. It is a real plus for the people of any small community in Alaska to have such a facility available to them, especially in the winter when so many other venues are closed.

The Denali Education Center would like to upgrade the Sheldon Center. The center does not have any bathroom facilities. In the summer, they provide portable toilets which are costly to rent and maintain each year. The requested money would be used to provide fully functional public restrooms adjoining the center. Although Elderhostel has changed its name to Road Scholar, the bulk of our participants are still elderly—in most programs we have people eighty or even ninety years old participating. The bathroom situation of having to leave the building and go outside to either the portable toilet or even further away to the bathrooms in the dining hall can be a challenge and disruption of the class for them.

There are also maintenance issues in the Sheldon Center—the roof leaks and the floor is only painted plywood which should be upgraded and sealed for long term use.

We are proud to work in partnership with the Denali Education Center on Road Scholar programs. We hope that our legislature will support them in upgrading their facilities for the comfort and safety of their participants, both Alaskans and the numerous visitors that the Denali Education Center attracts to the Interior in the summer.
