Detailed Project Description and Justification:

In 2010 members of the Alaska healthcare community joined together and developed a non-profit Medicare clinic to help address the shortage of primary care services for the growing and underserved Alaska Medicare population.

Recognizing the projected growth of the Medicare eligible population, the anticipated shortage of medical providers, and the increasing difficulty for Medicare patients to find providers, the Alaska Medicare Clinic was created as a pilot project and potential model that could be replicated in other communities throughout Alaska.

In cooperation with the State of Alaska and the Alaska State Legislature, the Alaska Medicare Clinic received funding in FY 2011 to assist with capital and start up costs.

Since opening the doors in May of 2011, the Alaska Medicare Clinic has seen over 2500 individual patients and has had over 10,000 patient encounters. Patient satisfaction with services, efficiency and staff is very high. The clinic has an excellent reputation in the medical community and is supported by numerous specialists in Anchorage. After twenty months of operation, and taking into account the complexity of the patient' health care issues, the clinic anticipates that with 2.5 FTE physicians on staff, the clinic will handle approxmiately 10,000 appointments per year.

The maximum number of daily patient appointment slots is significantly lower than originally projected when the clinic was built. Given the complexity of the seniors' health issues and the ever growing numbers of seniors seeking care at the clinic, 2 to 3 patients are turned away daily with a three month waiting list, the need for the clinic's services is not debatable.

2013 Legislature

A signifant issue that has occured since opening the Alaska Medicare Clinic is the reduction in the federal Medicare reimbursement rate. The reimbursement rate has fallen 5.5% since 2010. The reimbursement rate is a leading factor in health care professionals ability to care for and accept Medicare patients. This was a primary driver in the healthcare community coming together to provide a solution for Alaskans. The federal reimbursement rate for Medicare will likely continue to decline. Further reduction in the reimbursement rate will continue to exacerbate access to quality medical care for Alaska seniors.

This grant, in the amount of \$200,000 will assist the Alaska Medicare Clinic to continue to support its mission to provide essential health care assistance and care to Alaska's elderly citizens.
