The Department's facilities have continued deferred maintenance needs resulting from heavy usage by staff and client

Each building deficiency for every facility is rated in terms of urgency, fire/life/safety, security, building integrity, and mission efficiency. Together, these criteria are used to prioritize each project. Priorities given are generally followed, but may be changed due to higher emerging needs that may arise throughout the year.

These facilities are used to provide health care services, juvenile detention services, behavioral health services, and children's services. Maintaining the department's facilities is critical to carrying out the department's mission. This project will increase the useful life of the department's facilities.
