UAF Cooperative Extension Service (CES) interprets and extends relevant research-based knowledge in an understandable and usable form; encourages the application of this knowledge to solve the problems and meet the challenges that face the people of Alaska; and, brings the concerns of the community back to the university.

Core Services

- Supports the viability of communities and households through engagement with stakeholders that, in turn, guides the university on future research and academic programming.
- Programs are offered in areas including agriculture and horticulture; health, home and family development; natural resources and community development; and 4-H and youth development.
- Part of the largest informal education system in the world, connecting extension programs at land-grant colleges and universities in every U.S. territory and state.
- Offers hundreds of publications, written and produced by university specialists, which contain practical information of interest to Alaska residents. Many publications are free and available online.

Major Component Accomplishments in 2012

Extension had 83,184 direct contacts with Alaskans through its educational outreach, economic development and 4-H youth development programs.

The UAF CES presented over 450 workshops, throughout Alaska, in the areas of: health, energy, youth and families, food security and economic and community development.

Faculty, student and staff awards and competencies:

Julie Riley, Professor and Horticulture Agent, received the Distinguished Service Award from the National Association of County Agricultural Agents.

Derylee Hecimovich, Associate Professor and Agent, 4-H Youth Development, received the Distinguished Service Award from the National Association of Extension 4-H Agents.

Leslie Shallcross, Agent, Health, Home and Family Development Program, awarded the Partnership Award for Collaboration in Dissemination of Evidence-Based Programs, presented by the National Association of Chronic Disease Directors.

Key Component Challenges

Federal Smith-Lever funding will decrease to an unknown extent, causing reductions in programs.

Increasing integrated activities with research and meeting multi-state activity requirements is mandated by the US Department of Agriculture (USDA), National Institute of Food and Agriculture (NIFA) Smith-Lever funding.

Significant Changes in Results to be Delivered in FY2014

Continue to increase the marketing and publications necessary for engagement and outreach activities with a focus on programming areas such as: climate change, economic development, and food security.
