Provide the engineering design for a new float system, gangway, and dock utilities as well as the upland stormwater system and asphalt.

Funding Details:

Funds provided by the State for deferred maintenance were not adequate to upgrade the facility. The City used the funds for Shoemaker Bay Harbor on those items necessary to keep the harbor useable.

## **Detailed Project Description and Justification:**

Shoemaker Bay floats were installed in 1976 by the State of Alaska and had a useful life span of less than 30 years. Condition studies have been completed and it has been determined that smart money would replace the entire facility. The entire facility is at the point where it is not sound enough to invest rehabilitation funding into and doing so would be a waste of money.

The project would consist of the engineering design for an entire new float system, including pilings, electrical system and gangways. These floats would meet ADA regulations, National Electrical Codes and would be designed to accommodate vessels of this era as well as Wrangell's specific industry needs.

The uplands need to be redesigned to accommodate the new storm water concerns and regulations. Surface grading, drainage issues, oil/water separators and asphalt need to be installed for environmental reasons.

20% of the floats have already been condemned and closed and is rapidly deteriorating.

the funds obtained from the State's deferred maintenance facility were not adequate to bring up to standards, so improvements that made sense were completed.

#### **Project Timeline:**

Design of the new float system and uplands would begin upon receipt of funds.
