Detailed Project Description and Justification:

The FNSB is seeking a legislative grant to fund replacement of the oldest ambulance within the FNSB's ambulance fleet. The FNSB Department of Emergency Operations, Emergency Medical Services Division identified as one of its objectives the replacement of one ambulance.

This is an ongoing need as ambulance responses with patient transport continue to rise as the FNSB's population ages. In the FNSB's 2010/11 budget cycle there was an average of 7.26 ambulance responses per day with 1,830 responses requiring patient transport and 750 not requiring transport.

To keep up with this increase demand for services the FNSB needs to replace its oldest ambulance.
