We need to update our 40+ year old classroom furniture with innovative furniture that is easily reconfigured to meet a variety of interactive, cooperative teaching and learning. A more effective and efficient way to store student belongings – eliminating the tripping hazard of items falling on the floor throughout the course of the day.
