Detailed Project Description and Justification:

The Chignik Lagoon community has expressed the need for storing emergency equipment near fire hydrants within the village. The project will entail purchasing 10 outdoor fire equipment storage units and installing them next to the village's fire hydrants.

Currently, Chignik Lagoon Village Council has fire equipment stored in a shop which is located above the village. While the shop is relatively easy to access in the summer time, it is not always easily accessible in the winter time. In addition, there are residents who live in an area of the village which is difficult to get to in the winter time. They are mostly dependent on low tides to reach the rest of the village. These circumstances make it difficult to get equipment to the desired location in case of a fire. Currently many in this situation store the needed equipment outside near the fire hydrant or in a shed nearby. The village would like to organize this process and ensure that the equipment is readily available and properly cared for by providing a designated place for these valuable tools. These storage units will provide community members quick and easy access to fire hoses and equipment for emergency activities.

Project Timeline:

After the funds are made available, the village would purchase and order the needed equipment. It is anticipated that the supplies would arrive in the fall of 2014 and be installed and completed by the end of the 2014 calendar year.
