The City appropriated \$65,000 in 2014, and no State monies have been previously requested.

Detailed Project Description and Justification:

PRIORITY #3

Impact: Life, Health and Safety, Quality of Life, Historic Preservation, Economic Development

The Palmer Railroad Depot is owned and operated by the City of Palmer as a community center in downtown Palmer. The Depot is a heavily used community meeting place that hosts weddings, public and group meetings, craft fairs, agency training seminars and many other functions. The Depot is on the National Register of Historic Places, is a contributing building within the Matanuska Colony Historic District and is the centerpiece of Palmer's unique downtown.

The City appropriated \$65,000 in the 2014 City budget to install a fire sprinkler and alarm system in the Depot. This will provide essential fire protection for this historic building, but the building needs other significant upgrades to continue to serve as a central and popular meeting place for the Palmer community.

The City requests \$370,000 in State grant funds to upgrade the building's electrical system; replace interior and exterior doors; replace flooring; improve sound-proofing; upgrade the public restrooms; improve insulation and weather-proofing in the basement; repaint and repair interior walls; replace two obsolete boilers and heat registers; and reconstruct the building's east entrance to meet ADA standards.

Summary statement:

Following the process adopted in 2010 for developing, considering, and approving capital projects to be submitted to the Alaska State Legislature for funding requests, the designated projects in Resolution 13-032 are proposed as part of the 2014 (SFY 2015) draft budget. The City has followed the process and schedule by conducting a project nomination procedure and holding a widely publicized Project Fair and city open house. City departments have provided details and preliminary cost estimates to the City Council. Refined cost estimates and more detailed narratives will be developed following Council action on the project list. Work continues at the staff level to provide more detailed analysis and description of projects.

Due to a conflict of interest situation involving one of the priority projects, this resolution represents a partial list that may be acted on by the entire city council. An additional and separate project with its priority placement and request for approval is addressed by Resolution no. 13-033 and IM 13-049.

Projects which improve the quality of life and enhance economic prosperity of the City are prioritized to give the City of Palmer a strong basis for future growth.
