Funding Details:

\$200,000 has been applied for and secured through the Alaska Community Foundation, Pebble Fund Program. Funding has been received by the City and is available. \$25,000 has been budgeted from the City General Fund and is currently available

Detailed Project Description and Justification:

The City is the sole fuel provider in Nondalton. The city has been provided fuel to the community via a 2000 gallon fuel truck and a 1000 gallon trailer. Everts Air Fuel is the only vendor for air flown fuel and makes deliveries at 2000 gallon increments. During the fall and winter the City is unable to satisfy the demand for fuel due to lack of storage capacity. The annual City consumption (excepting the school and DOT) is 40,000 gallons of heating fuel and 15,000 gallons of gasoline and 1,400 gallons of propane. Last year the City was out of fuel for nearly three weeks. As a result the school district had to share their fuel stores, and residents were rationed during a brutally cold period. Residents are often rationed five or 10 gallons at a time during the winter months until another plane provides reserves.

With the new facility, the City will have the capacity to store enough fuel to ensure all residents and businesses have enough heating fuel, gasoline, and propane. The new facility would also provide the City the opportunity to seek cheaper barge/trucked fuel to minimize the cost of fuel to the residents and businesses in the community.

The City has dedicated property measuring 100' by 200' for this facility. This project will be designed to meet State of Alaska and Federal regulations for bulk fuel storage. The facility will consist of three 10,000-gallon double wall fuel tanks for heating fuel, one 10,000-gallon double wall tank for gasoline, a 1,000 gallon propane dispensing system, and a single two product island for dispensing heating oil & gasoline. The facility will be fenced and lighted. A spill prevention, control, and countermeasure (SPCC) plan will be produced for the City as part of the project. The attached budget includes all costs for tank design and construction, plumbing, fencing, lighting, and dispensing unit with shipping from Anchorage to Nondalton.


