Funding Plan: Total Project Cost: \$510,000 Funding Already Secured: (\$410,000) FY2015 State Funding Request: (\$100,000) Project Deficit: \$0 Funding Details: Anvik received AEA funding via the Interior Regional Housing Authority to contract a central biomass space heating project to serve most village community facilities summer, 2014 in the amount of \$410,000 but requires an additional \$100,000 to complete the project in 2014.

Detailed Project Description and Justification:

The Anvik Traditional Council has worked with the Interior Regional Housing Authority to obtain an AEA Renewable Energy Fund Round 5 funding award to construct a biomass heating station which will serve most the village's community facilities and thereby displace an estimated 20,000 gallons of expensive imported heating fuel oil annually. Due to the limited budget of \$410,000, the biomass project does not have adequate funds to extend heating utilidors to all nearby community facilities. A CIP request of \$100,000 is needed to fully extend utilidors to all nearby community facilities and as a result, maximize the benefits of this biomass space heating project.

The planned improvements to be funded with this requested CIP will be conducted during summer through fall. 2014.
