Detailed Project Description and Justification:

The gun range at the Eagle River Scout Camp has been in existence for decades. This facility, like the camp, is available for use by scouts from around the world, and by the public with permission. Each year, volunteers perform maintenance and repairs at the Eagle River Scout Camp. The effort is expended primarily by local boy scouts their adult leaders, and contractors and professionals, who donate their time, money, materials, and efforts to maintain and upgrade camp facilities as they can. The gun range is the beneficiary of this effort too, but volunteer efforts to keep it in good shape have not kept up with the effects of southeast Alaska weather, and normal wear and tear on the gun range. The gun range at the camp facility is heavily used and is in need of upgrades and repairs. Finally, a hiking and bicycle trail has been developed just behind the gun range target area. That poses a hazard to hikers and prevents the expansion of range use. Therefore, the money requested would be used to help plan, design, and construct an improved gun range at a better, safer location on camp property. Donated labor and materials and other donations will be used to meet this objective.

The project time line is on-going and expenditures will occur when funds are received. The implementation of design improvements will be coordinated with local volunteers and users.
