Brief Project Description:

This project will provide for a preliminary design and construction of a high use sustainable hiking trail that climbs near 2,000 feet up the South Side of Flattop mountain located at the East end of Canyon Road.

No funds have been provided for this project.

Detailed Project Description and Justification:

This grant would provide a single, long term and stabilized trail and rehabilitate existing human made social trails. Professionally designed and constructed, this sustainable trail will provide improved access to this popular area while increasing commercial opportunity and public safety.

Chugach State Park maintenance crews will be improving parking for recreational park users at the Canyon Road trail head in 2014. Improving parking will increase use, eventually causing degradation to the trails that lead not only to the Rabbit lake area but up the South side of Flattop and Peak Two. The popularity of this trail head has grown substantially over the last several years (more than 30,700 visits in 2013) and the associated trails are largely braided and suffering from vegetative loss, trenching and significant erosion.

Last year, an estimated 1.3 million people used the Chugach State Park and the Flattop Mountain area is one of the highest use areas due to its easy access from Anchorage. Visitors using the Park provide substantial economic benefit to the state through their use of local tour operators or guides; outdoor equipment and clothing sales; as well as associated travel and accommodation revenue. A recent study showed outdoor recreation in Alaska resulted in 9.5 billion dollars in consumer spending, 92,000 jobs and \$711 million in state and local revenues. An example of that benefit is the Anchorage opening of "Cabella's" a nationally know outdoor equipment retailer.

It is anticipated that visitor use numbers will continue to increase placing additional pressure on natural resources, trail systems and parking.
