Boys & Girls Clubs is a private non-profit corporation in its 47th year of service to Alaskan youth. Boys & Girls Clubs is affiliated with the national organization Boys & Girls Clubs of America and share their commitment to help youth of all backgrounds develop the qualities needed to become responsibile citizens and leaders. Boys & Girls Clubs' mission is to empower and inspire the diverse youth of Alaska to realize their full potential by offering them hope, opportunity and a safe environment in which to grow.

The Northeast Community Center and Boys & Girls Club are widely used by the Muldoon area community. Serving several elementary schools, Begich Middle School, and Bartlett and East High -- it has an active youth membership with high teen numbers. Community groups also regularly use the space.

One of the most needed resources is the kitchen. Free meals are offered to hungry youth every day. Meals are provided (cooked and served) by employees of Children's Lunch Box at no charge to youth. More than 23,000 meals were served to children in 2012!

The kitchen, while serviceable, is showing signs of wear. The refrigerator is requiring regular maintenance and has reached the end of what could reasonably be expected to be its estimated useful life. Flooring is old and cabinets and counters should begin being upgraded to commercial kitchen standards. Kitchen durable equipment for food preparation will be upgraded, repaired or replaced.
