# **Detailed Project Description and Justification:**

Boys & Girls Clubs is a private non-profit corporation in its 47th year of service to Alaskan youth. Boys & Girls Clubs is affiliated with the national organization Boys & Girls Clubs of America and share their commitment to help youth of all backgrounds develop the qualities needed to become responsibile citizens and leaders. Boys & Girls Clubs' mission is to empower and inspire the diverse youth of Alaska to realize their full potential by offering them hope, opportunity and a safe environment in which to grow.

#### Capital Request

30 Passenger Bus for youth transport youth to and from Club \$100,000

The Nikiski Club currently serves 95-100 youth per day. This Club has 223 current members.

Clubhouse staff provides after school and summer nationally recognized programming with proven positive outcomes. This includes academic assistance including before school Spanish and reading programs, after school tutors, homework assistance/completion, mathematics, accelerated math and reading, and character building workshops. We also provide enrichment activities including Karate, dance, swimming, sewing, cooking, photograpy, Robotics, arts, science, healthy habits, drama and community outreach programs. We serve nutritious and balanced suppers and snacks during the school

year and breakfast, lunch, and snacks during the summer through the State of Alaska Child and Adult Care Food Program and the Summer Food Sponsor Program.

The Nikiski Club has recently become the recipient, along with two of our other sites, of a 21st Center Community Learning Center Grant. We have agreed to bus students/Club members home in the evening during the school year and to and from the program during the summer months. Without such transportation, a large percentage of our members would not be able to attend or participate in our youth development and academic programs. The bus would also be used for educational field trips giving youth in a rural area the opportunity to explore and get exposure to places and things they may not otherwise have the chance to do so. In addition, the bus will ensure that kids and families that have transportation issues are able to benefit and participate in our programs, are fed a well rounded meal, and have a safe and positive place to be during the after school and summer hours.
