## **Detailed Project Description and Justification:**

This project would extend the existing natural gas line located within the Nikolaevsk community to the existing water treatment plant / maintenance garage and the multi-use facility currently under development.

Nikolaevsk' WTB heating system is 16 yrs old and due for replacement/upgrade. The council is considering upgrading the plant to be heated by natural gas. This would remove the need for a storage tank for heating oil at the WTB thus making it safer and in compliance with regulations for heating system fuel storage tanks at water treatment facilities.

The multi-use facility is in the design stage and is also considering to heat the facility with natural gas. Extending the line to these facilities would allow Nikolaevsk Inc. to go forward with its heating system upgrades.

The costs, estimated using Enstar' figure of \$22.59/ ft. for the 2014 construction season:

From Nikolaevsk School (end of line) to WTB - 3390.20 ft. x \$22.59 / ft. = \$76,584.62

Extension down Bubova Rd. to Multi - Use Facility - 942.08 ft. x \$22.59 = \$21,281.59
