Dredge and dispose of 20 years of accumulated sludge from the Lowell Point Aerated Sewage Lagoon.

Funding Details:

The Lowell Point sewage lagoon was constructed by the City of Seward. This request is for funding to dredge and maintain the existing facility.

Detailed Project Description and Justification:

The City of Seward is respectfully requesting the Legislature's support and funding to remove the sludge from Lowell Point Sewage Lagoon. The aerated sewage lagoon serves as the City's main residential wastewater treatment plant with a working volume of thirty million gallons. A concrete pony wall and membrane baffle separates the lagoon into two cells. Completion of this project will result in removal and disposal of forty-seven hundred plus cubic yards of sludge.

Lack of funding has led to twenty-four year's worth of sludge accumulation which exceeds the operational standard of an aerated lagoon. The State of Alaska's Department of Environmental Conservation has issued the City an Advisory letter regarding odors caused by the accumulated sludge.

Increased numbers of visitors and residents of the Seward area have contributed to the increasing volume levels at the lagoon. As development continues and Seward experiences continued growth this issue will become increasingly crucial.

The lagoon will be drained below the level of the existing pony wall and each cell drained individually. Cells, baffles, yard valves and all components pertinent to the lagoon will be inspected and repaired/replaced as found necessary during this process.

The Seward City Council has requested the city administration to bring forth a resolution to appropriate five hundred thousand (\$500,000) dollars to initiate design engineering, possible match monies, and emergency mediation and repair as
