Principal's Priority 1

Our School is in need of two intercom systems, one for our multi purpose room and one for our gymnasium. The intercom systems we have now are antiquated and the components needed for repair are no longer available.

Our school has a significant population of students with sensory issues. We are in need of a noise reducing system for the cafeteria. We are asking to implement the stop and go light system known as "Talk Light". This system is used in many schools throughout the district with great success.

Nunaka Valley has a significantly damaged floor in our multi-purpose room. The damage is due to poor construction and age. This damage has caused a significant "heave", in the floor which has cracked and split. The resulting damage now presents our school with a significant tripping risk to our students and staff. We are asking for funds to replace any damaged flooring in the school as well as the option for protective covering.

Benefits if Project is Funded

The new system will benefit the students and staff by allowing ease of communication during highly attended events.
