Winterberry Legislative Grant Request: Development of Outdoor Programming Space

Pertinent Facts:

-Over the past nine years Winterberry has moved from a K-6 school to a K-8 school and grown from 144 to 234 students. -Both Winterberry Charter School and the Anchorage community at large are in need of additional outdoor educational space for use year-round in the form of in-school curricular resources, community gathering/co-created interactive/learning gardening space, and additional summer program options for Anchorage's families.

-With these funds we plan to purchase materials and construct as a community the following supplies and learning spaces: - Various recycled/reclaimed materials from Central Recycling Services to be used in the construction of an outdoor

learning/experiential classroom, community amphitheatre and gardens, as well as an outdoor cob oven.
Various perennial plants, shrubs, and fruiting trees for to enhance the aesthetics of the area while also being utilized for expansion of learning opportunities.

• Using natural materials an outdoor early childhood (pre-K – grade 2) space will be created to support and encourage imaginative play that is connected to the natural world.

 Gravel, dirt, topsoil, sand, woodchips, and other necessary surface materials will be purchased for use in specific areas previously described as well as for the creation of the running/walking track. In Conclusion:

As Winterberry grows we are committed to developing further options for connecting our students to nature as well as connecting our school community with the larger community of Anchorage. Using these funds we will further develop places where learning can happen not only during the school day and year but at all hours and times of the year. Additionally, we have proven ourselves to be great stewards of the earth and our school environment. We will continue to operate in this fashion providing a shining example of the benefit of investing in education.

If completed, Winterberry's students will greatly benefit from additional resources to connect learning with the natural world. Additionally, such upgrades would serve the Anchorage community at large in the form of a venue for local performances and future summer camp opportunities for community members in need of quality programs for their children.
