Detailed Project Description and Justification:

The City of Kenai has for over 30 years utilized an aging undersized equipment shop and equipment storage building located at various locations, on leased properties. Presently a new 18,000 s.f. equipment shop is being constructed on property owned by the City. This project would complete the consolidation of City's the operations and maintenance facilities (heavy equipment shop, equipment storage, streets department, water & sewer department, and parks & recreation department) to a new campus, sited on property owned by the City of Kenai-General Fund.

The City owns and operates and utilizes well over 400 pieces of equipment in the conduct of its operations. This equipment ranges in size from six cubic yard loaders, to motor-graders, to end-dumps, to riding lawnmowers. The majority of our equipment must be stored outdoors exposed to the elements as no inside storage presently exists. This has caused, and will continue to cause, increased maintenance costs, shorter equipment life, and increased operational costs dictated by the need to continually "warm-up" dozens of pieces of equipment throughout the colder times of the year. In addition to the City's current equipment inventory, the City will be adding several pieces of specialty highway maintenance equipment to provide maintenance on roadways where the City of Kenai is assuming operations and maintenance responsibilities from the State of Alaska.

The construction of an equipment storage facility, along with the newly constructed shop will increase operational efficiency, decrease operations and maintenance costs, and will meet the City of Kenai's future needs for a minimum 25 year period.
