To build a boatdock and boardwalks leading up to the new eastside cemetary.

Funding Details:

City of Nunapitchuk has received funding from FEMA to build 24 boatdocks within the vicinity of Nunapitchuk but the new cemetary site was not included as one of the 24 boatdocks that needed repair.

Detailed Project Description and Justification:

Nunapitchuk resides on top of marshland and clay so the land is hard to walk on with tennis shoes or normal day to day office work shoes. There are mounds of tundra land around dangerous mossy land. In order to reach the new east side cemetary we need to build a boat dock with a 500 foot boardwalk about half a mile up from the river. This boat dock is subject to be 20 ft in length x 4 ft in width with 5 (2 ft x 4 ft x 20 in) poly floats attached to the underside of the framing structure, each structure is held in place with four 4-inch galvanized steel poles. Additionally, ramp extends from the shoreline to the dock attached in a manner to allow for river tidal ebb and flow. Two duck bill anchors will be in place to hold the dock from floating away. Eight inside corners and eight outside steel corners will be attached to the floats and frame of the dock. Outside corner and side bumpers will be attached to the dock as well. Ten 2x6x10' treated lumber will be set on top of the boat dock. 5/16" x 6" lag screws will be used to screw the lumber together and nuts and bolts for the outside and inner metal corners. Three Hundred Fifty 3x10x12' treated lumber will be ordered from The Lumber Yard and shipping from Seattle to Nunapitchuk by barge will be around 15,000.00-20,000.00. One supervisor at \$25/hour will be hired to watch the whole project and six laborers at \$20/hour to help complete the project. Administrative work will also be included.
