As you may know, the Fairbanks Pipeline Training Center Trust (FPTCT) is a 501 (c) (3) non-profit educational trust formed in October 2008 to develop, operate and maintain the Fairbanks Pipeline Training Center located in Fairbanks, Alaska. It is recognized by the Alaska Department of Labor and Workforce Development as a statewide regional training center and its focus is to provide training opportunities to Alaskans in the construction industry and in the construction, operation and maintenance of mainline pipelines, including the construction and operation of oil and gas process systems. While the Center's emphasis is in providing opportunities for Alaskans to enter into construction careers through federally registered apprenticeship programs and in the training of pipeline occupations, such as pipeline welders, this is not all we do.
