**ALASKA CLEAN WATER AGENDA ENHANCEMENT PROJECTS**

The Alaska Clean Water Agenda is a plan to unite the public and private efforts to protect and restore Alaska's water resources by taking the following actions:

- Identifying water quality initiatives and efforts that are underway;
- Recording what water bodies are polluted or in need of additional evaluation;
- Tracking down the sources of pollution;
- Developing statewide priorities for restoring polluted water bodies;
- Developing Alaska-specific solutions to clean up pollution;
- Developing best available technology and management practices to prevent pollution; and
- Involving interested stakeholders and the broad public in protecting and restoring Alaska's watersheds.

The Alaska Clean Water Agenda will go out for public review in 1999 and will be finalized early in the year 2000. The Agenda will be used as a planning document to determine water quality priorities in the State so that federal water quality funds and state resources are focused on the highest priority areas. Examples of projects which may be funded as a result of the Agenda include: storm water mapping, storm water enhancement projects (such as replacing culverts, designing detention ponds), developing Total Maximum Daily Load (TMDL) waterbody assessments for impaired waters, implementing TMDL controls, and monitoring waterbodies for rate of recovery and other purposes.
