Women's MH Unit

This fund source change completes the transfer of funding for the Hiland Mountain Women's Psychiatric Unit from MHTAAR to GF/MH. The 18 bed maximum-security unit will serve 100 women each year. The unit provides highly structured programming for women with acute and chronic mental illness. Each inmate has individualized treatment and after-care plans. Initial performance and outcome data indicates that the unit meets expectations.

Over 80 percent of the inmates served also have substance abuse diagnoses. This fund source change allows the unit to become a core state service, meeting the recommendations of court-appointed monitors.

In FY 1999 the Department of Corrections received a two-year \$2,000.0 federal grant to develop and implement a new management information system (MIS) to replace the obsolete OBCSIS system. This grant was a one time special appropriation for the State of Alaska, which was utilized in financing a multi-state collaborative MIS development project. The new system replacement core will be implemented during the third quarter of FY 2000 and all federal funds will be expended by the end of FY 2000. In order to continue operation of the new MIS, the Department requires \$240.0 GF to replace the one time federal funds.

These funds will be utilized to contract for and procure basic application licensing fees, software updates, hardware and software support. In addition, continued funding required for two Analyst Programmers and a Records Manager.
