**Brief Summary and Statement of Need:**

API's annual "stop gap" maintenance and repair request, as well as a request for the funds needed by API to make some very necessary fire/life safety upgrades. API Stop Gap capital funding is needed in FY 01 for on-going repairs to the 37 year old asbestos-ridden facility, until the planned move to a replacement (54 bed) facility can be completed. Basic maintenance at this aging facility is a safety issue for patients and staff as well as a legal requirement. The request also includes fire/life safety upgrades necessary to minimally meet local fire/life safety codes and JCAHO accreditation standards.

**Project Description/Justification:**

API's aging physical plant and grounds require annual maintenance to preserve minimally operational status. \$225.0 covers the costs of materials and labor. Much of this work is stopgap in nature, directly related to the aging and unsafe condition of the API facility.

In addition to the cost of materials and labor, an additional \$154.5 AHFC Rcpts is needed in FY01 for those fire/life safety upgrades necessary to minimally meet local fire/life safety codes and JCAHO accreditation standards (e.g., smoke detector heads, code compliant doors located along corridors, per the list below) before API is located in a replacement facility.

API Stop Gap \$225.0 capital funding is needed in FY 01 for on-going repairs to the 37 year old asbestos-ridden facility, until the planned move to a replacement (54 bed) facility can be completed. The funds are used to repair the building in compliance with current Federal and State hospital operations standards [i.e., OSHA, Joint Commission of Accreditation of Healthcare Organizations (JCAHO), Health Care Financing Administration (HCFA), and Alaska's health facilities Certification and Licensing requirements]. Basic maintenance at this aging facility is a safety issue for patients and staff as well as a legal requirement.
